## **Conservation Commission Minutes**

## Monday, September 24, 2012

Meeting was called to order at 7:30pm by member Alan Chaney

Members present: Juan Amodei, Judy Larter, Bill Moeller and Marilyn Pike

Meeting held: At the Dunstable Town Hall– 511 Main Street-lower level– Grange Room

# <u>Dan Ottenheimer – Mill River Consulting – crossing wetland</u> at 427 High Street

Mr. Ottenheimer asked to address the Commission regarding the 1 acre "Nyman" parcel on High Street. He explained that he would like to conduct soil testing in the rear of the lot which would entail driving over wetlands with a bobcat. Leah had met the site contractor out on High Street and told him that although she didn't see a problem, he should attend a Conservation Commission meeting to discuss the crossing. There is a brook that runs through the property which is approximately 6 feet at the widest point. Mr. Ottenheimer went on to explain that as a preventative measure 4x4's would be laid across the wetland. Judy made a motion to allow the crossing of the wetland at 427 High Street by bobcat in order to conduct soil testing (per Leah's site visit). Marilyn 2<sup>nd</sup> the motion. – Motion passed unanimously. It was suggested that the crossing be done before a hard frost and that Mr. Ottenheimer contact the office when they are at the site.

#### **Building Permit Signature – 379 Forest Street – Nigohosian**

Mr. Nigohosian attended the meeting seeking a signature on a building permit for a new home at 379 Forest Street. Since there aren't any wetland issues on the property, Bill made a motion to sign the permit. Marilyn 2<sup>nd</sup> the motion. –Motion passed unanimously.

## 67 Valley Street - Chellis' - Property Surveyed

Mr. and Mrs. Chellis told members that the lot line survey of their property has been completed. Mr. Chellis suggested that the Commission come out to the site to determine if there is a wetland violation on his property. The Commission told the Chellis' they will be out on Thursday, September 27<sup>th</sup> at 4pm.
