Review and Sign Bills and Payroll

The Secretary's payroll was signed.

Notice of Intent Hearing - Robert Bacon - Lots 1 & 2 Forest Street - 6:32pm

Leah opened the hearing at 6:32pm for Lots 1 & 2 Forest Street. Neil Gorman from David E. Ross Associates attended the hearing for Mr. Bacon. Mr. Gorman told members that there are currently two lots which will be subdivided into four, one with an existing home. Grading is proposed within the 100 foot buffer zone of a bordering vegetated wetland on lots 1 & 2. There is a non-jurisdictional wetland that crosses the two properties. A wetland specialist from David E. Ross flagged the wetlands. No one from the public attended the hearing. After the discussion on existing conditions and proposed work, Alan made a motion to close the hearing. Jeff 2nd the motion. – Motion passed unanimously. Orders of Conditions for the two lots were then written by the Commission.

Building Permit - Ken Tully - Lot 1 Massapoag Way

Mr. Tully presented a building permit for Lot 1 Massapoag Way. There is an Order of Conditions filed at the Registry of Deeds for the property. The building permit was signed.

Meeting Minutes of September 28, 2015

Jeff made a motion to approve, as submitted, the minutes of the September 28th meeting. Alan 2nd the motion. – Motion passed unanimously.

Certificate of Compliance (COC)-Christopher Deturk - 375 River Street
