ANR – Hardy Street (Carter) Property

Leah Basbanes, representing the Conservation Commission, attended the meeting looking for an endorsement of an ANR for the Hardy Street (Carter) property. She told the Board that she was requesting endorsement of the plan as well as a waiver of the \$200 application fee due to the fact that the Town was purchasing the property. This parcel, a total of 13 acres, will be split into a 2 acre parcel to remain with the family and an 11 acre parcel which will be purchased by the Town of Dunstable Conservation Commission. Jeff Rider reviewed the plan and questioned the property line running through a barn on the 2 acre parcel. Leah explained that the Carter family would be given an easement for the barn maintenance. This easement will be drawn up by Town Counsel, Rich Larkin. George made a motion to waive the \$200 application fee. John 2nd the motion. – Motion passed. George then made a motion to endorse the ANR plan for the Hardy Street (Carter) property. John 2nd the motion.- Motion passed.
