### 1054 Main Street - Special Permit Hearing Continuation - Ken Tully

Due to the lack of a quorum for a Special Permit hearing, the applicant has agreed to postpone his continuation which was scheduled for tonight. The last extension notice goes through April 8<sup>th</sup>; therefore, the applicant does not need to sign a new one. George made a motion to continue the Special Permit hearing for 1054 Main Street until Wednesday, March 26<sup>th</sup> at 7:30pm. Joan 2<sup>nd</sup> the motion. – Motion passed unanimously.

### Building Permit Signature - 270 Main Street - Miller property

A representative for the Miller's was in attendance seeking a building permit signature for a single family home on Main Street. The ANR was signed off back in 2012. There is a stone wall on the property, however, that section of Main Street is a state numbered/town maintained highway and is not under the jurisdiction of the Scenic Road Bylaw. George made a motion to sign the building permit for 270 Main Street. Joan 2<sup>nd</sup> the motion. – Motion passed unanimously.

### ANR Plan - Patriot Land Survey - 140 & 166 High Street - Gallant

Mr. Gallant and his engineer from Patriot Land Survey presented an ANR plan to be signed off. Jeff Rider had reviewed the plan and asked that "the plan show the distance and bearing to the two Town control points referenced in the notes". The plan was revised to address Jeff's comments. George made a motion to sign the ANR plan – 140-166 High Street – prepared for Richard W. Gallant and Susanna Harper Gallant, by Patriot Land Surveying, LLC, and dated 2/26/2014 with a revision date of 3/11/2014. Pls Job Ref #113-1070, Fld. Ref #P21/70. Joan 2<sup>nd</sup> the motion. – Motion passed unanimously.
