Indirect Cost Allocation Plan Agreement

The Secretary presented a letter to the Commissioners to sign asking the Town Accountant to transfer \$4,963.00 from the maintenance account to the Town of

Dunstable General Fund to cover a portion of the cost for employee benefits. Karl made a motion to sign the letter. Bob 2nd the motion. – Motion passed unanimously. *Note: Copy of letter in fiscal year 2013 expense file.*

Wells

Karl explained to Bob that Well #2 had had an issue in June. After much investigative work, including testing the Badger meter, it was found that the sensors were not working properly. Two options have been presented to the Water Department:

- a) Replace the existing sensors at a total price of approximately \$3,500.

 Benefit: Cost
 Problem: The sensors would be mounted as they are now, below ground, which is not optimal due to the changing weather conditions. Sensors would last 5-6
- b) Install an injection mag meter at a total price of approximately \$10,000.

 Benefit: Can tap live without shutting the system down. Not mounted below ground so sensor accuracy is better.

 Problem: Cost

Bob asked about maintenance and life expectancy of the injection mag meter. Karl said that he would find the answers to those questions and report back to Bob.

Karl mentioned that he had already talked to Town Accountant Andy Gould about the project explaining that these are specialized companies who previously installed equipment on our system and are quite familiar with its unique challenges, similar to a sole provider.

After the discussion, Bob made a motion to go forward with the new product (Injection Mag Meter) if the average life expectancy is 10 years or greater. Vendors that will be used are: True North (product), Smith and Felix Pipeline, and Walco. Estimated total cost of the project will be around \$10,000. Karl 2nd the motion. – Motion passed unanimously.

Mass Works Grant

Karl and Bob have not reviewed the Mass Works grant application. They will both do so over the next month.

Backflow Testing

The Secretary reported that Small Water Systems has completed the spring backflow testing.
