Minutes of November 13, 2014

The Community Preservation Committee (CPC) met on Thursday, November 13, 2014 at 8:00 AM in the Mural Room at the Duxbury Town Hall.

8:00 Project 2015-10;Bay Management Signs; Sam Davenport and Linda Brodie, Duxbury Bay Management

Sam Davenport and Linda Brodie explained that the project is to erect 3 large educational signs and a number of smaller secondary signs that will mark the locations of ways to the water and the locations of Town landings. Different types of materials were considered but for the large signs durability is of high importance. The large signs might include a chart of the bay with an overlay identifying landings, resource areas, no wake zones, etc. Sam Davenport said that the smaller signs are important because the access points are public property and some are being encroached upon by neighbors and that it is important to preserve open space. The cost estimate does not include maintenance. Holly Morris said it would be nice to have markers indicating egress points from the water side.
