# Town of Duxbury Community Preservation Committee 2016 APR 20 AM II: 20 DUXBURY, MASS.

## Minutes of February 25, 2016

The Community Preservation Committee (CPC) met on Thursday, February 25, 2016 at 8:15 AM in the Mural Room at the Duxbury Town Hall.

The meeting was called to order by Acting Chair Terry Vose at 7:00 pm.

# **PUBLIC HEARING 7:00 PM**

On a motion by Cynthia Ladd Fiorini, seconded by Kathy Palmer, the Committee voted 4-0-0 to open the Public Hearing. Terry Vose provided a summary of CPA revenues and project requests for this year. There were 3 proposals this year; 1 was withdrawn because it did not meet CPA requirements. There is an article to bind historic records in the Town Clerk's office, and another article to provide additional funding for the Merry property purchase (voted at the March 2015 ATM) which will be a Special Town Meeting article.

There was one person from the public present, Susan Curtis. She wanted to know if funds from the historic reserve could be used to prevent a historic house from being destroyed. Cynthia Ladd Fiorini explained that CPA funds are public funds and must be used to provide a public benefit. These funds cannot be granted to a private individual; funds have been granted to nonprofits that serve a public benefit. Ms. Curtis asked whether a public desire to save a house would fit these requirements; Tony Kelso explained that it has to be a building used for public benefit, not for private use.

On a motion by Cynthia Ladd Fiorini, seconded by Kathy Palmer, it was voted to close the Public Hearing at 7:30.
