### Minutes of June 16, 2016

The Community Preservation Committee (CPC) met on Thursday, June 16, 2016 at 8:15 AM in the Mural Room at the Duxbury Town Hall.

The meeting was called to order by Chair Holly Morris at 8:15 am.

#### **CITIZEN INPUT**

Diane Bartlett reported that there will be a dedicatioin ceremony next Saturday at 10:00 am for the Habitat house built at the Grange. A RFP was issued for the Feinberg Bogs Development and Habitat for Humanity is going to build the structures. Diane thanked CPC for their continuing support.

#### **OPEN PROJECT UPDATES**

#### Keene's Mill

Joe Grady updated the committee that the project will be rebid in an effort to be able to move it forward with the available funding.

#### **CPC Member Reports from Committees they represent**

Kathy Palmer serves on the Open Space and Recreation Committee. They are looking into the feasibility of having sidewalks installed in the Railroad Ave area. An update of the Open Space and Recreation Plan is in process. They are looking into expanding walking paths in several locations.

Cynthia Ladd Fioriini representing the Planning Board reported that the Planning Board is moving forward with the update of the Comprehensive Plan. They are prioritizing work for the upcoming year. Sidewalks in the area of the schools and at Halls Corner are being considered. They are developing a timetable for zoning proposals; the Battelle rezoning article will be presented at the fall Special Town Meeting. Tony Kelso expressed concern about two dwellings being allowed on one lot, and Holly asked whether consideration is being given to Climate change issues.

Terry Vose representing the Historical Commission said they have prepared a final draft of the Demolition Delay bylaw. The Plymouth 400 celebration is approaching in 2020 and it is hoped that the Myles Standish Monument can be cleaned up and there are other projects associated with this event that are being worked on.

#### Invoices:

On a motion by Terry Vose, seconded by Tony Kelso, it was voted 5-0-0 to approve invoice #I34681847 for \$631.90 from Administrative Funds to purchase printer ink at WB Mason.

On a motion by Cynthia Ladd Fiorini, seconded by Terry Vose, it was voted 5-0-0 to pay Anderson Kreiger invoice #11694 in the amount of \$971.80 to pay legal costs related to the Merry land purchase, using funds from Article 15 at the March 2015 annual Town Meeting.

On a motion by Cynthia Ladd Fiorini, seconded by Terry Vose, it was voted 5-0-0 to approve payment of \$9101 to Banner Environmental (Invoice #16-121) for asbestos abatement at the Merry barn; the funding comes from the Merry land purchase, Article 15 of the March 2015 annual town meeting.
