Minutes of March 16, 2017

The Community Preservation Committee (CPC) met on Thursday, March 16, 2017 at 8:15 AM in the McCloskey Room at the Duxbury Senior Center.

The meeting was called to order by Chair Holly Morris at 8:15 am.

Paul McCormack from the Housing Authority will be joining the Committee and was present but was not yet sworn in so could not vote.

Review of Town Meeting votes on CPC Projects

The CPC members discussed their reactions to Town Meeting. In general members were pleased with the support shown for the CPC articles. Holly Morris suggested that more in depth review of projects for historic preservation is necessary to address the question of whether a project is restoration or repair. Tony Kelso commented that there can be pushback about giving local nonprofits CPA money.

Cynthia Ladd Fiorini asked how to ensure that work has been completed prior to paying any invoices. It is important to continue requiring copies of final reports before paying any final invoices.

Holly Morris thanked all the members for the efforts they put in reviewing the various projects. She asked that the Bradford liaisons (Terry Vose and Sarianna Seewald) and the Alden project liaisons (Tony Kelso and Kathy Palmer) stay in touch with the project managers to monitor the progress of the projects.
