CERTIFICATES OF COMPLIANCE

SE18-1631; 34 Elderberry Lane: Joe Grady has inspected the property, the required documentation has been submitted, the project conforms to the Orders of Conditions and he recommends Certificates of Compliance be issued. RE-SIGN EXTENSION REQUEST VOTED NOVEBMER 3; SE18-1198, DUXBURY BEACH RESERVATION INC.

Due to an error with preparing the Extension, on a motion by Tom Gill, seconded by Sam Butcher, it was voted 5-0-0 to re-sign the Extension Orders for SE18-1198; Duxbury Beach Reservation Inc.

VOTE ACCEPTANCE OF KING LAND DONATION

Joe Grady explained that the Commission voted about a year ago to accept this, but the vote needed to include the provision that the Commission will pay any back taxes due on the signed Certificate of Vote. Therefore this needs to be re-voted. On a motion by Sam Butcher, seconded by Robb D'Ambruoso, it was voted 5-0-0 to accept the King Land donation including the payment of any back taxes due.

PROPOSED PROJECT CHANGE; 17 SURFSIDE WEST

An RDA for this location was recently filed for a deck replacement; at that meeting the applicant, Arthur Vancini, was asked by the Commission whether he intended to replace his shed, and he said no. He now intends to replace the shed, which requires the installation of two additional sonotubes. The replacement deck is smaller than the original deck. Joe Grady asked the Commission if they felt a new RDA should be filed for this additional work, the consensus was that a new RDA should be filed. Mr. Vancini will be advised that he needs to file another RDA for this work.
