#### PROPOSED TOWN MEETING ARTICLE—RECALL ELECTIONS

Mr. Witten said that he has reviewed the proposed language. He had several recommended changes. After extensive discussion, the following motion was presented:

Mr. Donato moved that the Board insert an article providing for recall elections in the Town of Duxbury, as drafted by Mr. David Lowery on November 30, 2009, with the following changes: A) The number of registered voters required to file an affidavit is raised from ten to one-hundred; B) The number of registered voters who must sign the recall petition is raised from 5% to 10%; and C) The last sentence of Section 7 is removed (pertaining to future appointments by a recalled official. #### **TOWN MANAGER BRIEF**

- 1) The Massachusetts Department of Transportation sent a letter of support for traffic signals at the intersection of Routes 3 and 3A. However, no funding was offered. the Town of Duxbury is encouraged to coordinate efforts with the Town of Kingston and private developers in an effort to expedite this project.
- 2) Construction costs were \$2.4 million in November. There was one home construction project that cost \$1.2 million.
- 3) There was an H1N1 vaccine clinic today at the Duxbury Middle School.
  Approximately 500 injections were administered. The clinic went well. Mr.
  MacDonald thanked members of the Duxbury Bay Area Medical Reserve Corps, the Board of Health, and school staff.
- 4) Firefighter John Montosi was honored on November 29 for his heroic actions resulting in the rescue of a Pembroke woman from a house fire. He was awarded the Medal of Valor.
- 5) Connor Clarke, as part of his Eagle Scout application, has completed a mapping of graves at the Duxbury Cemetery. This information will be useful to many individuals and organizations.

## **ANNOUNCEMENTS**

- 1) Ms. Sullivan announced that she attended the annual meeting of the Duxbury Beach Reservation. She noted that the Reservation does not intend to raise its fee for the Town's 2010 beach lease. She also announced that the Reservation may apply for a seasonal wine and beer license for Duxbury Beach Park.
- 2) The primary election to fill the seat of U.S. Senator Edward Kennedy will be held on Tuesday, December 8 at the Duxbury Middle School. Polls will be open from 7:00 AM to 8:00 PM.
- 3) The Town Manager will be making his FY2011 budget presentation at the Selectmen meeting of December 14, 2009.
