{REDACTED} He then stated that Johnson Golf has agreed to the current total settlement amount of \$695,000, but if they have to wait until a fall Special Town Meeting, the total amount increases to \$750,000. Attorney Kreiger mentioned that the next steps would be to determine if the Town should wait until Special Town Meeting and how to pay this.

Mr. Madden discussed options for financing the settlement. He stated that we can pay now, which would create an appropriation deficit prior to setting the tax rate. Mr. Madden further stated that he has already contacted the DOR and is awaiting their response. The Selectmen all agreed that they prefer to save the community money and pay this now instead of waiting for a Special Town Meeting and pay an extra \$55,000. Mr. Dahlen stated that there should be a public announcement and press release of this settlement including the reason for paying this now. Mr. Read asked what the voters would be voting on at the Special Town Meeting. Attorney Kreiger stated that they would be voting on the source of funding. Mr. Dahlen asked what would happen if the Town voted no to the funding. Mr. Madden replied that the funding would be built into the tax rate process as a one-time hit. Mr. Madigan reiterated that in any event, this has to be paid and would rather pay it now to get it over with and to save money. Attorney Kreiger also said that the Board of Selectmen has the authority to settle lawsuits in the best interest of the Town, and this is being settled for approximately 1/3 of the judgment plus interest.

Mr. Dahlen moved that the Board of Selectmen settle the Johnson Golf Management, Inc. v. The Town of Duxbury case in the total settlement amount of \$435,000. Seconded by Mr. Flynn. Vote: 3:0:0
