- 1 Moderator for a term of 1 year
- 2 School Committee members for terms of 3 years
- 1 Planning Board member for a term of 5 years
- 1 Library Trustee for a term of 3 years; and
- 1 Duxbury Housing Authority member for a term of 5 years.

Mr. Flynn suggested that there should be 2 Library Trustee seats and asked that this be double checked.
