

Town Government Study Committee  
Minutes 1/27/2016

Ms. Ordway began her discussion with forms of government. She indicated that recently there have not been many changes from open town meeting to representative government. Towns have had difficulty filling the representative positions. She stated that recently towns have been considering the Town Council form of government. Approximately 10 towns have made this change. She compared it to moving from having selectmen to having a larger board.

She next made comments on checks and balances in the financial arena. She applauded many of the current practices of Duxbury. She described their Community Compact work, including coming up with financial policies and best practices. She spoke at length about the role of an Audit Committee. She then described their capital planning and forecasting work.

In terms of consolidating services, Ms. Ordway said they have worked in four areas: facilities, purchasing, IT and some personnel departments. She touched a little on each. She stated that they have only seen four communities who have fully merged school and town finance areas: Barnstable, Harvard, Brockton and Reading (who unmerged with a change of school committee members). She said there are several instances of partial consolidation between school and town. She later described recent regionalization in the areas of animal control and veterans affairs.

Ms. Ordway commented on the recent approval of the Town Manager Act, which was explained by Shawn as a clarification process to the first Act passed previously. She commented on Duxbury's early ATM date and how difficult it might be on the budgeting schedule. There was discussion about split Town Meetings (financial meeting in June, all else in April). She inquired about the Personnel Board, indicating that many have been eliminated with the professionalization of town management.

She described the difference between the Community Compact and the Technical Assistance Bureau work. The latter makes suggestions and provides support using more standardized materials and resources. The Community Compact is an initiative of the Governor and Lieutenant Governor and provides a more tailored product. Compacts can be made in three areas: financial, environmental and IT. She also indicated that staffing reductions have resulted in the Community Compacts being more efficient, as there are state funds available to outsource the work to consultants such as the Collin Center.

After Ms. Ordway and Mr. Kalivas left at 8:45, the group discussed the potential value of these services. The selectmen are the decision-makers, as the DOR requires they issue the request for services. We discussed possibly engaging them for: review of govt structure, capital planning (5 years and longer than 5 years), areas of consolidation (school/town), checks and balances or best practices (e.g. Audit Committee suggestion). We are currently doing a study through the Collin Center regarding the town's IT so we did not pursue this area.

Ann and Susan stated that the survey is live. There was the suggestion that we try to get the Clipper to give the survey a marketing push. They expect results prior to Town Meeting.

With Town Meeting approaching, it was decided that Gay will draft a summary of the Committee's activities for discussion at the next meeting. It was generally felt that a written submission was sufficient. The Committee's need to respond to the petition to change the ATM date was discussed; it was decided that we would form our response and response format at the next meeting.

The Committee's next meeting is on February 24<sup>th</sup>. We will meet at the Senior Center.
