- 1. Finalize Demolition Delay Bylaw Guidance Document for Homeowners
 - a. Minor corrections made to page 1
 - b. Motion to approve with corrections as final text was seconded.
 - c. Motion Passed w/4 in favor, 1 opposed. Commissioner Lawrence opposed, in lieu of further review and discussion.

2. Interview Helen Fowler

a. Helen is a long time Duxbury resident and former school teacher concerned with the extraordinary changes made to the nature of the town. Former Conservation Commission member. Currently taking a mandatory one-year leave from the Cultural Council, to which she plans to return. Helen is available for monthly meetings and walk-arounds.

3. Interview Molly Sheehan-Curtin

a. Molly has been in Duxbury for 1 year; Served on the Historical Society in Trumbull, Connecticut performing genealogical and social research.
