Mr. DeAngelo explained to the Board that in order for the Center at Sachem Rock project to proceed, it would be necessary to demolish the barn at Sachem Rock Farm, due to the feasibility of the project.

To appropriate an amount not to exceed \$3,750,000.00 for constructing, renovating, equipping and furnishing the Center at Sachem Rock, Plymouth Street; to authorize the Treasurer, with the approval of the Board of Selectmen, to raise this appropriation by borrowing an amount not to exceed \$3,750,000.00 under G.L. 44 s3A; and to authorize the Board of Selectmen and the Senior Center Building Committee to take all other action necessary to carry out this project; provided however that this vote shall not take effect until the town votes to exempt from the limitation on total taxes imposed by G.L. c59 s21C (Proposition 2 $\frac{1}{2}$) under the provision of debt exclusion, amounts required to pay the principal of and interest on the borrowing authorized by this vote.

M/Condon, s/Miksch, a unanimous vote approve the request of the Senior Center Building Committee to place an article, presented by Chairman DeAngelo, on the February 7, 2010 warrant as follows:

"Shall the town of East Bridgewater be allowed to exempt from the provision of proposition two and one-half, so called, the amounts required to pay for the bond issued in order to pay for constructing, renovating, equipping and furnishing The Center at Sachem Rock Farm."
