Town Clerk, Marcia Weidenfeller and Town Moderator, Robert Looney were present to go over the Annual and Special Town Meeting warrants for the June 7, 2010 Annual Town Meeting.

Town Administrator's Report

Mr. Samia explained to the Board that he has received several calls with regards to the sign recently placed at Sachem Rock Farm indicating the "Future Home of the Center at Sachem Rock Farm". Mr. Samia stated that the sign indicates the hope of the Senior Center Building Committee and that no money has been allocated for the building; that the decision will be made by the voters of the Town. The Board suggested that Mr. Samia contact the Senior Center Building Committee to place the word "proposed" on the sign, in order to clear up the confusion.

Mr. Samia explained the budget was currently at a -3% and pointed out that the DPW Union jumped on board last week with the wage freeze. Mr. Samia further explained that \$99,000.00 was added back into six departments, who were in need, as a result of the wage freeze and that the Town is not looking at layoffs within the departments that took the wage freeze.
