Board Discussion

Chairman Crowley discussed a report received from the Office of the Inspector General regarding contract violations in the East Bridgewater Fire Department. Chairman Crowley read a summary of the report for the record. Mr. Crowley further stated that the Inspector General's office recommended further training for all East Bridgewater officials involved with purchasing goods or services or the construction bidding projects should immediately seek training on all Massachusetts laws and regulations pertaining to public procurement and that Town Officials should consider sanctions against Brian Healey Contractor, Inc including barring him and subcontracts from Public Works projects because of his submission of false and misleading documents in connection with the roof replacement contract and should also consider barring Mr. Whittemore of Sun Rise Roofing and Mr. Cara-Donna of Cara-Donna Roofing because of their collusion according to the Inspector General's Report.

Chairman Crowley explained that the training process has already begun and all officials who may be involved in procuring goods and services will undergo the Office of Inspector General's on line procurement training, with the second step being an in-house session with the our Town Counsel to address any specific questions or situations and finally several employees, one from General Government, one from the School Department and a third person as an additional resource will undergo the IG's more in depth training to become a certified public procurement official should there be another occurrence no one will be able to say that they didn't know or weren't aware or weren't trained or it's not their fault.

Chairman Crowley stated that in regards to the possible criminal violation alluded to in the report there is no indication that if the IG plans to make a referral to the Attorney General for further investigation to determine if a criminal violation occurred that something the Board will have to contact them about to see what the process is for that.

Chairman Crowley further stated, with the Inspector General's recommendation, he would make a motion that the Town of East Bridgewater suspend the eligibility of Mr. Healey, Mr. Whittemore and Mr. Cara-Donna for the award of any public contract by the Town of East Bridgewater as a result of the alleged submission of false and misleading documents as per the November 2012 Inspector General's Report.

M/Crowley, s/Connors, a unanimous vote, to direct the Town Administrator to seek and identify any available training on Massachusetts Procurement practices and to direct all department heads to obtain the necessary training as required.

M/Crowley, s/Connors, a unanimous vote, to direct the Town Administrator to work with Town Counsel to review all purchasing practices and policies and make changes to comply with public bidding laws.

M/Crowley, s/Connors, a unanimous vote, for the Town Administrator to direct Town Counsel to contact the Inspector General to request that the Attorney General is notified if the Inspector General has concluded that criminal activity occurred.

Mr. Samia reiterated that fact that the training process has already begun; with several employees already completing the training.

Police Chief John Cowan was present to report to the Board and the public that he and several of his officers met with Superintendent Cote, the three Principals and their staff at the Central, Middle and High Schools and parents to discuss the tragic events that occurred in a school in Connecticut this past Friday. Chief Cowan explained there will be an upcoming show on cable in regards to what Police and the Town is doing to ensure the safety of the students.
