### **TREE WARDEN'S REPORT**

Tim Bockus reported on the following:

The past month 5 letters were sent to residents in reference to tree issues. The town notifies the resident of the complaint. The following homes received letters: 278 Goodwin; 62 Margery; 16 Rolling Meadow; 1564 Main Street and 588 Forest Street.

The following areas were investigated:

- 44 Rowland Drive – limbs hanging
- 140 Chipper Drive – town trees
- Landers Court – checking property lines, trees may be owned by the town
- 107 Ellington Rd – town owned trees leaning toward neighbor's home
- 68 Cummings – town owned trees – will be removed

Tim further reported that Goodwin College had donated roses which were planted around the sculpture in Alumni Park. Goodwin College has offered landscaping design services to the town and will be addressing Wickham Library, Brewer House and Town Hall.

The America the Beautiful Grant had 4 bidders and work should begin by the end of the month.

The Flood Protection Project is continuing in town.

Discussion was held in reference to the work the utility company is doing to remove limbs to allow a clear zone for power lines.

**OLD BUSINESS:**

A. Spring plantings

Chair Sirois stated the barrels look nice.

B. Memorial Trees

Chair Sirois stated she did not have the memorial cards printed because of the concern as to where trees could be planted in town. Discussion was held and the following recommendations were made:

- Gold Star Pool area (behind Goodwin School)
- Silver Lane Cemetery (Chair Sirois will go with Tim Bockus to look at the areas recommended.)
