#### CONCERNS OF THE COMMISSION

The following concerns were addressed:

Brewer St - #743, #808, #826

Concern for tree trunks around town in resident's front yards with grass going around them. Greg Donato addressed this issue stating that the company hired by CL&P to trim and remove trees did have paperwork signed by the homeowner stating they would be responsible for the removal of the tree trunks, etc once cut down.

Tolland Street – mattresses – Tim Bockus stated that it is a daily stop to the home by Public Works Larrabee Street – staging in yard. Greg Donato stated that his department is watching the home, and said that as long as some activity is taking place with the home it is not a violation.

Greg Donato replied to last month's concerns and emailed the information to the clerk who forwarded to all Commissioners.

## TREE WARDEN'S REPORT

- 6 Landers Court private trees
- 826 Tolland Street dead tree, hazard is gone but is unsightly

- 888 Oak Street Maple tree, limbs falling in road
- 25 Laraia hanging limbs private tree
- 487 Burnside dead tree
- 643 Forbes (corner of Norige) dead tree
- McCauliffe Park tree removed
- 140 Chipper Drive town tree fell and damaged shed

Tim Bockus informed the Commission that letters do go out to property owners and when there is no response, he sends the letter Certified Mail.

America the Beautiful grant has been granted to F.A. Bartlett Tree Service, tree inventory in the business district will begin shortly.

Tim Bockus informed the members

- that the civil works project at the river dikes and levees is continuing
- Rte 15 new sound barriers being installed by the DOT
- He completed a Tree City survey for the State department looking for feedback from the community
- DOT is surveying Main Street because they will be installing a bicycle lane on Burnside Avenue which may continue to Main Street and Connecticut Boulevard
