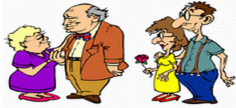
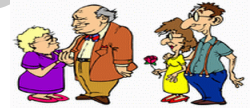

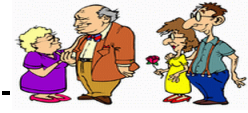
**MEETING CALL TO ORDER:** AT 2:05PM

MADE BY PAT LANCASTER, SECONDED BY EDMOND LALIBERTE.

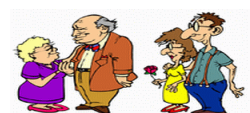
**OLD BUSINESS :** SENIOR PICNIC – LILLIAN REPORTED FINAL BILL
