8) NEW BUSINESS

a) Hoffman Motors - HX Project - Business Incentive

- i) Sam Pines and Dennis Zelesky of Hoffman Motors spoke before the Commission requesting financial assistance in the form of a tax abatement for the HX Project occurring on Connecticut Boulevard in East Hartford.
- ii) After the representatives from Hoffman excused themselves, the Commission discussed different options concerning the recommended amount of financial assistance to grant Hoffman Motors. It was the Commission's opinion that a figure of roughly \$90,000 to \$100,000 for a total tax break would be sufficient. It was decided that a recommendation would be made in the form of a percentage rather than a whole dollar amount.

MOTION MADE BY MR. RYAN, SECONDED BY MS. PET TO RECOMMEND TO THE MAYOR AND TOWN COUNCIL THAT A 3 YEAR TAX ABATEMENT, 20% THE FIRST YEAR AND 10% THE FINAL TWO YEARS, BE GRANTED FOR HOFFMAN MOTORS. APPROVED UNANIMOUSLY
