- a) Business Visitations

- b) Community Economic Development Fund Main Street Improvement Program Donna Wertenbach, CEO

- i) Ms. Wertenbach informed the Commission that East Hartford has been named as a target city, 1 of 3 that CEDF will be focusing on for their Community Development Project. This program will bring together neighborhoods, empowering them to make decisions on the direction of their community. This will be funded by investors, both individuals and large companies, who will see a guaranteed return + 2% on their investment with the possibility of 5%. The town will be assigned a CEDF Consultant who will assist with the projects throughout the life of these investments, which are currently being estimated at 3-5 years.
- ii) Members of the Redevelopment Agency agreed to work cooperatively with the EDC to begin CEDF's involvement in the town.
