COMMISSIONERS' SPECIAL MEETING, AUGUST 30, 2012

The Commissioners of the East Hartford Housing Authority held a special meeting on Thursday,
August 30, 2012 at the Authority's central office building located at 546 Burnside Avenue, East Hartford,
Connecticut. The meeting was called to order by Chairman Robert N. Keating at 12:35 p.m.

2. <u>Discussion and Possible Approval Upcoming Annual Budgets</u>

Mr. Regan reviewed with the Board the Annual Budgets for federal and state.

The Commissioners and staff discussed the budget and specific questions and comments were made in regards to the following items and questions were answered by Mr. Regan: Other Income, Legal Expenses, Salary, Benefits, Asset Management, VT Management, Insurance Policies, King Court income, Utilities (fuel oil), Sewage reimbursement, other office expenses, electricity, gas, provisions for repairs, debt service.

Mr. Regan stated the other line items in the budget collectively were adjusted to be consistent with the actuals that we are spending this year which are reduced in most cases historically.

There was a discussion regarding an energy performance contract and possible cogeneration, solar or geothermal being done here when this building is rebuilt.

There was a discussion regarding the capital fund money the Housing Authority will receive and use of those funds.

Mr. Regan explained that CHFA wants the numbers in 30 days before the beginning of the year and HUD does not have that requirement but stated that we are doing both of them today.

The motion was made by Commissioner Yamamoto to approve the East Hartford Housing Authority operating budget for 2013. Vice Chairman Kate seconded the motion, it was carried by the unanimous vote of the Board of Commissioners.

The motion was made by Commissioner Yamamoto to approve the East Hartford Housing Authority Resolution No. CT013-85-08-2012 approving the HUD portion of operating budget. Vice Chairman Kate seconded the motion, it was carried by the unanimous vote of the Board of Commissioners.

as the Special Legal Counsel for Specialized Labor Relations Matters for the housing authority for a one

year term. Vice Chairman Kate seconded the motion, it was carried by the unanimous vote of the Board

of Commissioners present.

There being no further business before the Board of Commissioners, a motion was made by Vice

Chairman Kate to adjourn the meeting, which motion was seconded by Commissioner Yamamoto

and was carried by the unanimous vote of the commissioners present. The meeting was then adjourned
