

## East Windsor 250<sup>th</sup> Anniversary Committee February 16, 2017 East Windsor Historical Society

The February 16, 2017 planning meeting for the 250<sup>th</sup> Anniversary Celebration of East Windsor met at the Osborn House of the East Windsor Historical Society.

Bill Thim made a motion to approve the January 5, 2017 minutes. Lynne Tracy-Thim seconded the motion. The motion passed.

**<u>Time Capsule</u>**: Nothing new to report this week.

## Planning Committee:

Slogan Contest: The slogan contest deadline has arrived. We received nineteen submissions, all from the high school entry box. All entries were read in the meeting. The winners will be decided by a committee made up of Chairperson Rebecca

Talamini, EW250 representative Lynne Tracy-Thim, and EWHS representative Diane Lajoie. The winners will be announced officially at a ceremony presenting the scholarship checks.

The Revolutionary War Reenactment group is available for June 16, 2018, rain or shine. Scout Hall is already booked for the 16<sup>th</sup> for the Food Truck Festival. The two events will complement one-another nicely. The events will include a flag ceremony, recreation of part of Israel Bissle's ride, a skirmish, tents showing displays of how people lived in the time period (medical care, cooking, washing, etc. They have also offered to send someone in costume to the schools to talk about the event. The charge is \$1200 to \$1500 per day. We will also look into having horseshoe and cornhole tournaments. The Revolutionary War Reenactment group previously met with Bill, Lynn, and Ceil to review the Scout Hall grounds. They think the area near the pond at Scout Hall will be perfect. They need potable water, an electric supply, and enough room for the reenactment, tents, and spectators.

The Parks and Rec. department will make sure there are no soccer games scheduled on the day of the event so we can use the parking lots. Once the date is set for the reenactment, Ceil can start to schedule the food trucks.

# Lynne Tracy-Thim made a proposal to officially book the Reenactment for \$1500. Diane Lajoie seconded the motion. The motion passed.

Winter Festival: We are looking into a Sleigh Rally for our February Winter Festival. Ian Neill has been playing phone tag with Jim Stremper from the Draft Horse Association.

The Victorian Lady: The senior center would like to host the Victorian Lady presentation in March 2018. They are also talking about hosting a tea party. Poster Contest: Now that the Slogan Contest is concluding, do we want to start the Poster Contest in April or in the fall? We discussed the pros and cons to both dates. The kids' artwork will be available for posters and merchandise earlier if we advertise for them in April. However the project has a better chance of receiving support from the art teachers in town if we give them notice about the conditions now and ask them to add it to their curriculum in September. The terms still need to be finalized, but we are looking for original artwork no smaller than letter-sized paper and no larger than 11" by 17" paper. We also discussed the need to find a better word than contest, since there aren't going to be any winners or losers.

The Warehouse Point Library has expressed interest in hosting one or more historical lectures by Bill Hosley.

Cub Scouts meet on the second Wednesday of the month. They are thinking about hosting an outdoor movie night and creating a float for the parade.

Masquerade Ball: The deposit was sent to La Notte on Monday February 6, 2017. **We still need more volunteers**. This is going to be a very involved committee. If

#### **Fundraising Committee:**

Father Dan agreed to put our fundraising kickoff letter in the church vestibules at St Catherine and St Phillip churches.

Andy Hoffman spoke with Woodworth Press in Warehouse Point about creating envelopes with our Logo as part of the return address. They quoted \$228.90 for 5000 envelopes or \$136.50 for 2500.

## Paul Anderson made a motion to design and print 10,000 envelopes. Lynn Tracy-Thim seconded the motion. The motion passed with one abstention.

We need to get four 3 by 4 foot wooden signs to post at the main entrances to the town to let people know about the 250<sup>th</sup> anniversary.

We discussed getting a thank you note card or postcard for our donors.

Some business donors require a letter on Town letterhead with the town's tax id on it. We will ask the town treasurer for a copy of such a letter. It will be available to the businesses upon request.

We will get a list of the top 50 business tax payers in town to approach personally for donations.

Ceil Donahue ordered 100 baseball caps for \$8.50 each. They are embroidered hats in the design we approved on February 2<sup>nd</sup> with East Windsor Connecticut added to them. We will sell the hats for \$15 each. They should be in by the March 2, 2018 meeting.

Rebecca found a company out of Canton, CT that can create commemorative coins for us. The 1 ½ inch coins with the EW250 logo on one side and the Town Seal on the other will cost about \$3.90 each including shipping. Rebecca is going to price plastic sleeves for the coins. The company does sell velvet protection boxes for about \$1.50 each. We will also look into a ring to encapsulate the coin to make a key chain out of it.

Calendar: We want to produce a calendar with both town and EW250 event dates on it. There is a person on Griffin Road who produces calendars. We will need the calendars printed by October so we can sell them at the Four-Town Fair. In addition to photos from around town, we would like each month to contain some facts about East Windsor.

We discussed the need to make the costume adjustable so different volunteers can use it. Someone also asked if the EW250 logo would be on the costume.

Four-Town Fair: Marie Latellier from the Four-Town Fair discussed East Windsor's participation as hosts of the September 14-17<sup>th</sup> 2017 Four-Town Fair. The Four-Town Fair planning committee meets on the third Wednesday of the month. They get 30,000 people a year. We can get a concession table to sell our merchandise; they have both indoor and outdoor opportunities for concessions. They will also have a kids' stage where we could schedule a presentation. We can submit a float for the parade.

#### **Rebecca** Talamini made a motion to adjourn. Paul Anderson seconded the motion. The meeting adjourned at 8:18 pm.
