7. **COMMUNICATIONS:**

There will be 2 flu shot clinics held, one on 10/24 from 10-12 p.m. and the other on 10/30 from 2-4 p.m. at the Town Hall meeting Room.

8. MONTHLY REPORTS:

A. Town Financial Reports FY 18-19:

Amy O'Toole, Town Treasurer, stated that she did not have a whole bunch to report. She stated that Tax Collection is at \$18,191,647 collected. \$646,000 has been collected from the Fire District but the Town has already paid them all of the \$670,000 that they get. She stated that the agreement with the Fire District is that the Town pays it in full up front and then the Town collects it throughout the year.

She states that of the \$19 million collected by the Town for Revenue \$18 million is in taxes, the Town has received very little other money. She states that with Expenditures the Town has spent \$6.3 million of the \$39 million budget so far and that BOE has spent \$2 million of their \$23 million budget.

NO Transfers were needed this month.

She stated that the First Selectman's CNR Capital is really the Unallocated and she feels it should be renamed Unallocated so that people know it can be used but it does have to stay in CNR. The other 2 changes were under Open Space in the Town Planner in lieu of having open space requirements in the developments and the same thing with sidewalks.

She also stated that the Town is not in compliance with the State of Connecticut Uniform Charts of Accounts. The uniform is not uniform.

9. BOARD OF SELECTMEN UPDATES AND REFERRALS:

First Selectman Maynard brought a copy of a online resident survey from the Charter Revision Commission that will close on November 20, 2018. There will be a forum on December 6, 2018 to discuss the results. To see the survey it is hereto attached as Attachment A (2 pages).

He also stated that the Town is looking at the 99 year lease for Scout Hall. They are trying to figure out who will pay for what and try and figure out the wording. The Town feels they should cover things like siding, roofing or doors. An attorney is involved to help figure this whole thing out.

He also stated that the Town is considering buying the Sabonis property from the Open Space fund for \$16,000. To see the property being considered it is hereto attached as Attachment B (2 pages).

He stated that he spoke to the guy from Calamar and there have been no workers there but things are starting to move forward and they should be getting back to work soon.

Lastly, he stated that 140 Wapping Rd gravel pit was asking for a special use permit. There was a lengthy discussion how that was not a good decision.

10. BOARD OF EDUCATION UPDATES AND REFERRALS:

They stated that the BOE has a deficit of \$91,000 stemming from special ed. Tuition and transportation and from substitute teachers. There have also been multiple repairs already which were about \$30,000.

11. NEW BUSINESS:

A. Annual Report & Table of Contents:

Amy stated that the annual report has no table of contents and is not in alphabetical order. She stated that they will have a draft for the November meeting. They had quotes from




