Resident Services Report East Windsor Housing Authority March 2016

In the absence of a Resident Services Coordinator for Park Hill, the Executive Director and the Executive Assistant will be providing services and programs for the residents. The following monthly report has been written by the Executive Director.

Resident Activities

The Tenant Association continues to sponsor varies resident activities such as Coffee Hour scheduled for every Tuesday morning and monthly pot luck suppers. The Tenant Association continues to provide an integral role with the well-being of the Park Hill residents and liaison to management.

Community Programs

The Visiting Nurse Association provides a monthly free blood pressure screening at Park Hill. On March 15th a representative from the VNA again visited Park Hill and presented an educational discussion regarding "Preventing Hospitalization and Re-hospitalization" to our residents. Approximately seven residents attended. Food Share has a mobile truck that continues to distribute free food from the Saint Catherine's parking lot every other Friday. Several of our residents participate with this very important program.

A representative from the Town of East Windsor Social Services Department will be at Park Hill on March 21, 2016 to assist our residents with the Energy Assistance application. This is a wonderful program to help our residents with their utility bills.

Upcoming Resident Programs

Classes for Chair Yoga will continue this Thursday, March 24th at 1:30pm in the Park Hill Community Hall. A new instructor will be teaching the classes. Due to personal reasons, the previous instructor could no longer commit to teaching on a weekly basis. This program is funded through a state funded grant for one year. Approximately, every eight to twelve weeks, we have a hairstylist available in the Park Hill Community Hall to cut our residents' hair for a \$12.00 fee. Executive Director's Report

March 2016

Management-

I recently met with the consulting firm, TAG Associates to discuss development plans for the 7 acres and capital improvements for Park Hill such as upgrades to the bathrooms and kitchens in the apartments. TAG Associates is an independent consulting firm recommended by the Connecticut Housing Finance Authority as part of the revitalization movement for Housing Authorities.

The Resident Services Coordinator resigned on March 14, 2016. Until this position is filled, the responsibilities of this position will be shared by the Director and the Executive Assistant.

On Friday evening, March 11th, the residents and staff hosted a celebration for the recent acquisition of the 7 acre parcel that was formerly owned by the Town of East Windsor. Several members of the Board of Selectmen and Board of Commissioners were present as well. Many thanks to all the residents who brought a variety of delicious refreshments.

South/Phelps Road

I met with the First Selectman to discuss the delinquent land lease fees resulting in a shortfall on income and anticipated expenses. A few of the South/Phelps Road homeowners are not paying their fees. The First Selectman will be presenting this issue to the Board of Selectman for a resolution.

Projects-

<u>Mold</u>

As previously noted mold was evident in a few of our apartments due to the insulation in the attic areas not being distributed properly. This has been corrected and the apartments effected were retested for mold by a professional environmental hygienist. The results indicate that the mold has been eradicated.

Water System

The Utility Superintendent from Connecticut Water will be reviewing the blue prints for the Park Hill current water system. We can then discuss further options for converting our well system to the Town water supply.

Other Matters-

Critical Needs Funding

The Connecticut Housing Finance Authority has funding available for projects that would be defined as a need that is urgent and threatens the health and safety of the residents. Replacing the Park Hill sidewalks qualifies for this funding. A percentage of our reserves may need to be used towards this project if we choose to proceed with the project. I continue to work with CHFA on processing the application.

Small Cities Grant Application

I am continuing to work with Wagner Associates on the application for funds to upgrade the fire alarm system in each building, renovate all three laundry rooms to be ADA compliant and replace our existing generator. The application is due April 11th. On Monday, March 14th there was a Public Hearing held at the Town of East Windsor specifically to discuss the Small Cites Grant. There was no public opposition to the planned projects. Several of the Park Hill residents attended to support the proposed projects.

Capital Improvement Fund

An application was submitted to the Connecticut Housing Finance Authority for funds to replace the exterior front and back door apartment light fixtures. The State will match the dollar amount up to \$25,000 for each development that has recently been completed a project by a Housing Authority. Our recent energy efficient upgrades by Eversource for each of the three Park Hill phases (levels) will qualify for this program. The total incentive cost of the upgrades was \$46,871. The new light fixtures and installation will cost \$46,982.

Vacancies

We are 100% occupied and no pending move outs.
