On Saturday, March 21, 2009 at the Town Hall Annex a Bream & Design breakfast will be held from 10:00 a.m. to Noon for kids to design a playground. They will have the opportunity to try out components of the system as well.

For fundraising events a monthly Friday night movie and popcorn, beginning March 27, 2009, will be held at the East Windsor Middle School for grades 5 through 8. Cost is \$5.00 per child and they get to choose the movie.

Director Green is a developing a bowl-a-thon event at Bradley Bowl possibly during April vacation. Teams will compete against each other or against other Towns.

#### a. Financial Accounts Review

The annual Kids Fishing Derby will be held on Saturday, May 2, 2009 at the East Windsor Park. The Club is seeking a \$250 donation towards the purchase of prizes for the Derby.

### d. Park Director's Report

Director Green reported there will be a Boards and Commission training session at the Town Hall on Thursday, April 16, 2009 at 6:00 p.m. on how to run a meeting, etc.

Director Green stated that the Shovel Ready projects as submitted to Congressman Larsen's office are now being passed through Senator Dodd's office.

Chris Spada is participating in the Keep It Green project on March 28, 2009 from 10:00 a.m. He is asking for any resources the Department could contribute to this project. Parks and Recreation could contribute trash bags and disposable gloves.

Director Green informed the Commission that there is \$15,000 in the CIP/CNR Account allocated to Warehouse Point Park/Osborn Field. She is working on a plan to spend those funds.

### Other areas for consideration are:

East Windsor Park – Update the Pavilion bathrooms, kitchens and build a storage area; replace baseball fence cap material, update/replace park signage.

Pierce Memorial Park – paint the basketball court, install a new backstop, update the swing set and purchase a new sign with a picture of Bernard Pierce.

#### **NEW BUSINESS/d) Park Director's Report (continued):**

Director Green has updated the Facility Use Application for rentable fields use and wills place it on-line.

Director Green has received many requests for field usage at Abbe Road Soccer Complex. The requests are for games on Wednesdays, Thursdays, Saturday and Sunday. She is in the process of working out the scheduling for that facility.

Summer employee applications are coming in and will close on April 2, 2009.

#### e. Groundsman's Report

Park Director Green reported that the large equipment is being serviced and repaired. It was necessary to install new motor mounts on the tractor. Turf Products is coming out to evaluate why the mower tires have unusual wear so early in its life cycle.

Spring materials are being ordered such as line paint, grass seed and fertilizer. Groundsman Tetro is looking to replace the fencing at East Windsor Park in location of the tennis court and 1st parking lot that borders the adjoining property owner.
