a. East Windsor Dog Park

c. Bathrooms at Osborn Field

The bathrooms at Osborn Field are up and functioning. New hand blowers have been installed. One came damaged and will be installed when the replacement arrives. Some small details will be finished when the temperature becomes warmer. There is now hot water in the bathrooms and available to the snack bar.

The Director has been informed that there will be dollars moved from this departments full time employee time line and moved to another department. This is possible since the Park and Rec full time employee did not start until fall. The

b. Park Directors report.

There are several upcoming events: The Color Walk/Run will be held on Saturday, May 13 in honor of the Lady in Red, Nancy Fortner. The Dance Recital was held this past Saturday, May 6 and was successful. The Fishing Derby, held on May 6, was well attended. The Director stated that interviews for summer positions have begun. Staff Training for the summer staff will be held on June 7 and East Windsor Park will open on June 10. Summer Fun Camp and Swim lessons begin on June 26. So far the department has received 5 Financial Hardship requests. Care for Kids will not be accepted this year. The state has issued 15 mandates that must be met in order to receive fund and there is no provision in the budget to meet these mandates. Should the need arise, the Department will make other arrangements to help those families should. Each year there are only one or two families that use this program. Abbe Road and East Windsor Park Pavilion rentals are coming in. The new part-time assistant started last Tuesday, May 2, 2017.
