4. Old Business/a. Defined Benefit Plan for Public Works Bargaining Unit, Becky Sielman, Actuary from Milliman – benefit comparison analysis:

Committee Member Bilodeau wanted to preface her vote by noting when she votes the rationale is because of what she thinks will happen over a long period of time.

MOTION: As discussed with the Actuary, to APPROVE a Town hybrid plan as

presented below to the Public Works Bargaining Unit to be offered to

those hired after 7/1/2007 as soon as possible.

DB component: Employee contribution rate is 3%, Benefit multiplier is

1.25%, vesting at 100% after seven (7) years.

DC component: Employee contribution rate is 2%, Town contribution

rate is 3%, vesting at 100% after seven (7) years.

Members currently in the DC plan will be permitted to purchase service in

the DB component retroactive to date of hire.

Strempfer moved/E Bowsza seconded/

DISCUSSION: Committee Member Strempfer indicated for the record that this is by far one of the toughest decisions he has had to make since his involvement in Town government. He suggested the fiscal cost filtering down from the State is unsubstantiated. Committee Member Strempfer felt the timing is not good, but the Town needs to have qualified employees. Committee Member Corso indicated she echoed Committee Member Strempfer's comments. Sometimes when she votes she can't vote on her personal feelings; she must realize she is representing the Town, which makes it hard. She also feels the timing isn't great. See Committee Member Bilodeau's comments preceding this vote.
