#### A. Personnel Matters - Time Donation

Following a brief discussion regarding time donation, Commissioner Mancuso made the **MOTION** presented below. **MOTION** was seconded by Commissioner Filipone.

#### **MOTION:**

I make a motion to allow sworn and civilian members of the East Windsor Police Department – from the Police Union, Dispatcher Union, Clerical Union, and Administrative Police Staff – to allow them to donate sick days to Dispatcher Sharon Bourke due to a serious and long-term illness, under the following guidelines:

- The donated sick time, made by each individual employee, will be collectively placed into a separate bank of time to be administered by the Chief of Police or his designee, to provide Dispatcher Bourke time, as she needs it, thereby not creating a property right to the time if not used while also providing the assistance that she needs.
- This separate bank of time will be distributed to Dispatcher Bourke until it is exhausted or no longer required.
- If time does remain in the bank, the sick days will be partially returned to the employee who originally donated it in a fair and equitable manner, as directed by the Chief of Police or his designee.
- At this time, the total days of donated sick time equals **66** ½ **days**, and is donated by the individual employee as documented by the attached sheet, which includes their name and total of days donated.
- If Dispatcher Bourke requires more sick time, further requests can be made to the East Windsor Police Commission.
