**UNFINISHED BUSINESS:**

- a. "Mansions at Canyon Ridge" (formerly Mansions on Scantic) – Nothing new.
- b. East Windsor River Guide /SRWA Guides – Currently available at Broad Brook Bookstore.
- c. Canoe Trips on Scantic / Flood (River) Review – Reported that 5 canoes and kayaks were seen on river. Again asking for info re fallen trees or washouts.
- d. Trail Markers – New yellow diamond shape ones will be placed on trees with aluminum nails per DEP regulations.
- e. Membership – A few Members will probably be changing their status to alternate due to outside commitments. This will help in our getting a quorum at meetings.
- f. Activities – April 25: Albert Grant would be leading a hike on Bald Mountain start time 10AM.
