- 5. ON-GOING / OLD BUSINESS:
- a. River Review water level is high/low then high again; muddy/clear and muddy again after rain.
- b. Water testing Regular monthly testing and the weekly E. coli testing continues with E. coli levels very high after our rains. Dr. Martin will be continuing the testing herself going forward for the rest of the season, in Enfield and Somers until her supplies run out and East Windsor until mid-September.
- c. Scantic River State Park / Filter Beds 3 Work parties totaling 18 hours had members working on cutting back overgrowth on the yellow trail, with more still to do. Six hours spent identifying the best route down to the brook to build the bridges for easier passage.
- d. Bottle Receptacle Good activity has enabled the purchase of waders for members who help in the blueway maintenance.
- e. RTP Grant Award New grant opportunities available, with an October 31st deadline for submission of application. Discussion ensued regarding applying for the balance of our original grant to finish the Braille trail. It was agreed that we go forward seeking the additional funding.
- f. Community Night Out had our table set up but little activity as the crowds were limited due to the dire weather forecast. But we tried every opportunity to tell residents of our mission and seek new help.

g. Membership – Sue Gaffney Sullivan now a full time member, leaving 1 full membership open and

alternate slot still available.

h. Social Media/publicity – Deb Talamini said nothing new posted.
