First Selectman Robert Maynard called the meeting to Order at 7:01 p.m., in the East Windsor Town Hall, 11 Rye Street, East Windsor, Connecticut.

Mr. Maynard reminded everyone not to interrupt people when they have the floor and only to speak when recognized. Mr. Maynard also reminded everyone that they should treat everyone civilly and respectfully.

## 7. <u>COMMUNICATIONS</u>

Selectwoman Nelson asked if the Fire Marshall could come in and go over his report and explain a few things. Mr. Maynard stated he would ask him.

First Selectmen, Maynard stated that Parks and Recreation was sponsoring a "Lady In Red" Color Fun Walk/Run on May 13<sup>th</sup>. To see the flyer it is hereto attached as Attachment A (1 page).

## 8. PUBLIC PARTICIPATION

Mr. Maynard went over the rules of speaking during Public Participation for the new people that were present.

**Paul Anderson** – Stated that in minutes of the Board of Finance Meeting on March 22<sup>nd</sup> it was questioned in the Building Repair and Maintenance Line that covered all Town buildings. The maintenance of Scout Hall was mentioned and questioned. Mr. Anderson stated that Scout Hall Building Committee is a Lessee and they rent that Town owned property. He states that it is not their responsibility to make Capital Improvements on that property. He stated that the Scout Hall Building Committee submitted a 5 year CIP Plan on September 14, 2016. He is not sure what happened to it after that. He states that because they are a Lessee they are not part of the Budget and can't ask for Town money. Selectmen Bowsza asked where the plan was submitted because he had not seen it. Mr. Maynard and Mr. Pippin both stated that they had seen the plan.

**Bob Leach** – Stated that Scout Hall Building Committee is just a committee that leases the building and that if a CIP request came in it should have been from the Building Department or Public Works for building maintenance. He just wanted to point out it was not the obligation of the Scout Hall Committee.

**Selectwoman Nelson -** Asked Mr. Leach about the Police Commission regarding what was going on with them in general. He stated that the new hire has graduated the police academy and starts FTO training this week. They put an officer in training similar to SWAT raining.

**Selectwoman Nelson** – Stated there was an article in the JI on Wednesday, April 12<sup>th</sup> having to do with the employee health claims with the new State regulated co-op. They switched over to and it saved the Town \$95,000. She gave the article to Mr. Maynard and he stated that they had looked at the plan but thought it was not competitive. He said he would take another look at it.

# A. East Windsor's 250<sup>th</sup> Anniversary Commission Report:

Rebecca Talamini reported that the t-shirts should be in on May 4<sup>th</sup>. They will be having a booth at the walk for Abby's Helping Hand this weekend and will be selling merchandise. She also handed out a tentative calendar for 2018. To see attached calendar it is hereto attached as Attachment B (1 page).

#### B. Broad Brook Mill Site Remediation:

Mr. Maynard stated that they are going to apply for a grant for revitalization of Brown Fields. UTAS gave the Town permission to apply for the grant. It would be anywhere from \$200,000 to \$2 million. One thing that would be done with the money would be a new roof on the main building. Mr. Bowsza asked when DEEP would be coming and Mr. Maynard stated he had not talked to DEEP yet.

#### C. Discussion of the Casino:

Mr. Maynard stated that there was a public hearing that he talked about and it was in the paper. He stated that on Friday they received a petition to have a Town Meeting on an Ordinance that

involves the casino. He states that they are looking into that. It was given to the Legal Affairs Subcommittee. There were over 20 signatures and they were certified. Mr. Bowsza asked what the next step would be and was told that it would be to see what the Legal Affairs Subcommittee decided to do. Mr. Bowsza stated that the Town Attorney was asked to look at this and it turns out it was more difficult than originally thought. He states there is no case law that has anything to do with this type of referendum. He states that the statutes are silent on it and the Town's Charter is in conflict with itself. He thinks that they absolutely need to certify the petition and send to Town Meeting. April 27<sup>th</sup> is the last day they can do it. He thinks that they need to hold a Special Meeting on Thursday to give the Town Attorney a little more time to look it over.

**MOTION** made by (Nelson) and SECONDED by (Pippin) to have a Special Meeting Thursday, April 20<sup>th</sup> at 7 p.m.

Mr. Maynard called the meeting back to order at 7:39 p.m.

#### D. 1% BOE Fund Rules:

Mr. Maynard stated that the Board of Education is looking for MOA that will outline what the 1% could be used for. Mr. Maynard stated that the Board of Finance should be involved in this so a plan can be developed on how to approach the MOA. Mr. Pippin stated that the money should be turned back over to the tax payers if there is a surplus. Mr. Bowsza stated he had asked for information from the BOE and has not received that information yet. He had also asked what they have spent year to date. Selectwoman Nelson stated they spend everything anyways and use their budget to the fullest extent. She thinks they should be budgeting wisely enough to anticipate issues as they arise. Mr. Maynard stated that maybe there needs to be a meeting and it was stated that the request has been brought up before. They promise information and it is not delivered. Mr. Bowsza feels a joint meeting should be held between the BOS, BOF and BOE. It was suggested to have the meeting on May 2<sup>nd</sup>.

#### E. South Road Oil Spill and Payment Approval:

The homeowner has submitted a claim to her insurance. The hole has not been filled in but a better fence has been put up surrounding the hole. After a brief discussion it was decided that there is some additional information that needs to be looked into. It was suggested by Mr.

Bowsza that it be put on the agenda for Thursday night's meeting and Mr. Maynard stated he would do that.

The American Heritage River Bridge Project on Melrose was discussed and all of the members present thought it was wonderful. 250<sup>th</sup> Birthday was discussed and they are thinking of having pictures of before and after. Inland Wetlands Watercourse Agency, 2 applications, and they were both approved. He stated that the wall at the Osborn House is beautiful and it is made out of salvaged stone.

May 3<sup>rd</sup> at 8 a.m. there will be a preconstruction meeting for the repairs for the Scout Hall Pump Station. The Town owns it and will have to pay for it. Mr. Bowsza asked if Len and Joe have been involved at this point, he was told that it was unclear and Mr. Bowsza stated that they should be from here on out. He was told they would be from now on.

**Tom Talamini** – Stated that April 15<sup>th</sup> there was a tractor pull and there were many more people than last year. He stated that while driving through Somers there are a bunch of yard signs stating "Not In My Town" and it is a discussion on the Opioids problem. He could not catch the date and time as he drove by.

**Bob Leach** – Stated he wanted to clarify that the 1% funding is not additional funds for the budget that it is 1% from their actual budget.

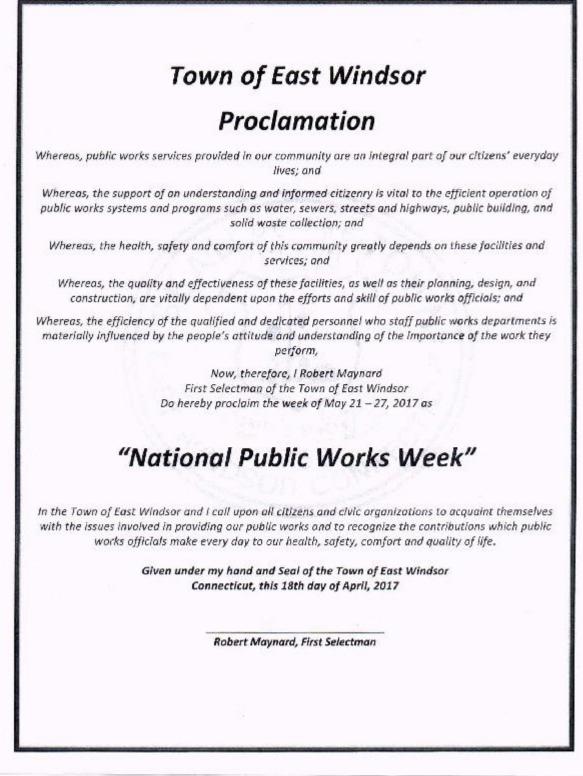

Selectmen's Report - April 18, 2017

On April 5, I attended the Board of Education meeting. I was extremely disappointed that the Board allowed the superintendent to unilaterally commit the Town to sending more students to more out of district schools, without a vote of the Board. The superintendent gave her word to a handful of parents that something was going to happen, and it was then represented to the Board that "we don't want to go back on her word." This is nothing short of a usurpation of democracy.

After discussions I had with state Department Education representatives and reviewing Connecticut General Statute 10-65(b), it is clear that this is a policy decision that commits the town for many years to come (at least 7). This should have been voted on by the elected board, not decided by staff. I even went back to review meeting minutes from past BOE meetings where this was discussed, only to find that there was only one instance where it came up, and still NO VOTE by the elected board members.

I am thoroughly disappointed, but not at all surprised at the outcome.

This is one reason why voters in town don't have faith in town officials. They assume that everything has been cooked up in the back room beforehand and outside of the democratic process. Unfortunately, tonight, it sure appears that they are right.

On April 11, the Planning and Zoning Commission met. The commission held a public hearing on a proposal to resubdivide a lot on Scantic Road. The current owners plan to sell of at least one of the building lots, or leave them to their children.

Commission also reviewed the Town's aquifer protection regulations. Commissioners asked pointed questions about the application fees and renewal fee structures. Commissioners noted the frustrations felt by many businesses already, and that in order to achieve business retention in town, we should be more aware of the excessive fees already placed on businesses. It was noted, unfortunately, that many of the fees imposed on local businesses are set by either state statute or regulations. They discussed a streamlined, layman's terms flow chart for the aquifer review process.

Commissioners also discussed the concept of implementing an overlay zone over some parts of the Route 5 corridor intended for development according to the Town's POCD. This would allow property owners to retain their existing zoning, but also allow those properties some flexibility as to future use of the properties. This would allow for development in conjunction with the POCD, whether that is a casino or some other economic development. It would streamline the development process for anyone within the zone boundaries, and doesn't create a hardship for anyone. The overlay zone is a business friendly concept. Commissioners were comfortable allowing staff to move forward with a more fully developed proposal for a future meeting. Any such proposal would need to go through the normal public hearing process.

The commission also considered making changes to regulations pertaining to earth excavation. They considered things like hours of operation, daily trips, minimum acreage, and so on. Im very pleased that tonight's Town meeting passed an ordinance waiving building fees associated with the replacement of crumbling foundations. This is some that I've been advocating for since last summer, and is long overdue. Hopefully, this will provide some comfort and relief to families afflicted by this devastating occurrence.

4/5/2017 Board of Education - Auditorium 7:30 PM Outstanding students - Gianna Hutchins BBES, Allison Bancroft EWMS, and Isabella Puziewicz, EWHS. Limerick Contest there was 65 entries with 4 winners (tie in the 2<sup>nd</sup> to 4<sup>th</sup> grade). Public Participation - Emily Syme spoke to the board about supporting EWHS and the Rockville Agri-Science Center; sending students to Suffield will be detrimental to both programs. She also stated she gets on the bus at 5:55 am and arrives at school at 7:20 am (the travel time on the bus should not exceed one hour). What will happen when the Students going to Suffield (14 miles from Emily's home) and Rockville (4 miles) have to use the same transportation (it was stated by Dr Kane this would cost neutral)? There were 3 parents that spoke in favor and a letter read from Lois Noble. School reports - BBES Empathy and Giving- goal was to teach and model empathy and sense of giving, this is completed through school wide charitable acts (Veteran's and Valentine Day letters to the Veterans, Visiting nurse association food drive, Can tabs for Shriner's Hospital, Concert for the Senior Center, and hat and mitten drive for Five Corner Cupboard). EWMS supported National History Day. Community Partnership award was approved by all. The last day of school is June 15th. Unfinished Business BBES Window project are due in mid May, the abatement only requires plastic barriers, planting and sidewalks need to be completed as well. Alliance Capital Grant #2 has been delivered and it will take about 30 days - this is not CIP projects but must do issues. It was noted that the last BOF meeting the school budget was set at a 2% increase in spending. There were microphones set up at the head table, however I could not hear (3rd row on the left center); 1 did hear something from Dr Kane about a FOI request if the BOE was discussed and not properly put on the agenda. She also stated something about either a vacation or leave of absence - again it was not clear. The trip to London, England will take place. There was a lot of discussion regarding a policy for the Agri-Science program - at this time Dr Kane committed to the parents that the 5 students will attend Suffield.
