Town of East Windsor Special Town Meeting August 21, 2013

A Special Town Meeting of the Town of East Windsor was held at the Town Hall, 11 Rye Street, Broad Brook, CT on August 21, 2013. The meeting was called to order by First Selectmen, Denise Menard at 7:30 P.M. Motion was made by Dale Nelson and seconded by Linda Sinsigallo to nominate Denise Menard to preside as Moderator. Linda Sinsigallo made a motion to have nominations cease, seconded by Marie DeSousa. Both motions passed unanimously. Moderator, Denise Menard asked the voters if they would consider waiving the reading of Item #'s 12 & 13 because they are so long. She provided everyone with copies of all the resolutions. Richard Leborious made a motion to waive the reading of the account numbers on item #'s 12 & 13, seconded by Richard Pippin, Jr. Motion passed unanimously. Town Clerk, Joanne M. Slater read the call to the meeting minus the account numbers on item #'s 12 & 13. Moderator, Denise Menard read the statement of eligibility to vote.

The following resolution was introduced and read by Leonard Norton.

Item #1: Resolved: For Fiscal Year 2012-2013 - To recommend transferring \$1,550.00 from 1-01-20-5295-2-200 Conservation of Health /Life Ins. to 1-01-40-6395-2-201 P & R FICA & Medicare Leonard Norton moved that the foregoing resolution be adopted, seconded by John Burnham. No discussion followed.

The resolution passed unanimously.

The following resolution was introduced and read by James Richards.

The resolution passed unanimously.

Dale Nelson read that this item is no longer necessary as it included in item #13. Therefore this resolution was not voted on.

The following resolution was introduced and read by Joseph Pelligrini.

Joseph Pelligrini moved that the foregoing resolution be adopted, seconded by John Burnham. Discussion followed.

It was asked what EE stands for. Denise Menard answered that EE stands for Employee Benefits. Denise Menard stated that we had a reduction in our employee benefits because all the bargaining units in town agreed to one insurance policy rather than the nine polices we had previously. This gave some savings to do other things with. This particular resolution is for filling the gas tanks at the end of the year. It was questioned if we exhausted all the gas we had in surplus. Denise Menard answered, yes.

The resolution passed unanimously.

The following resolution was introduced and read by Alan Baker.

Item #5: Resolved: For Fiscal Year 2012-2013 - To recommend transferring \$4,767.80 from 1-01-55-9445-7-799-0737-0 CIP Current Town IT HDW/SFTW to 1-08-55-1025-7-799-0661-0 CNR Town IT Alan Baker moved that the foregoing resolution be adopted, seconded by Kathleen Pippin. Discussion followed.

Denise Menard said that this resolution has to do with an IT project. They did an overhaul of the entire IT. We put this in our capital improvement plan for last year. It came in under the amount that was

projected and that money now goes in to our capital non-recurring for this coming year. Because it's labeled a capital project we have to move it over to capital non-recurring. There is plenty of IT work to do.

The resolution passed unanimously.

The following resolution was introduced and read by Marie DeSousa.

It was questioned if we have a full time Human Services position in the town hall. Denise Menard said they no longer have a Human Services position. They have a Social Services position which is a combined position. They eliminated one union position and made the human services and the Senior Services one position and increased the salary slightly.

The resolution passed unanimously.

The following resolution was introduced and read by Chris Mickey.

The resolution passed unanimously.

The resolution passed unanimously.

The following resolution was introduced and read by Richard Pippin, Jr.

Item #11: Resolved: To recommend amending the Ordinance # 00-4 Establishing American Heritage River Commission, Section 2, to read as follows:

Section 2. Terms of Office:

Four member's terms shall expire on November 1, 2002, four member's terms shall expire on November 1, 2003 and three member's terms shall expire on November 1, 2004. Alternate member's (4): two terms shall expire November 1, 2004. All terms thereafter shall be for four years.

Richard Pippin, Jr. moved that the foregoing resolution be adopted, seconded by John Burnham. Discussion followed.

Denise Menard stated that there were no alternate terms spelled out in the original ordinance. When they were getting ready to reappoint the alternates they were confused as to how to do it. The Board of Selectmen voted to have a clarification of that in the ordinance itself. It was questioned whether the dates were correct in this amendment. Denise Menard stated that the dates are when it originated. It is starting at that point and then we go from there. It was questioned with all the terms going 4 years, aren't the Selectmen going to have a problem with filling them? Denise Menard said that the regular members are staggered terms and the alternates are not. This amendment is just for the alternates. It was stated that it looks like this amendment is saying that all terms shall be for 4 years for both regular & alternates. Denise Menard said that the alternates are for 4 years starting at the same time & ending at the same time. The regular members are on staggered terms.

The resolution passed unanimously.

Robert Little called point of order. He asked is this approved budget June 11th supposed to have been on the website, is that the baseline budget? He said that the Town attorney said to use the June 15th budget and to apply the 2% down the line item. He said we don't have a June 15th budget and this resolution is not doing it with what is posted on the website. It was questioned if we need to have a resolution on the floor before there is discussion. Denise Menard said that we need to have a motion on the floor first in order to talk about this.
