

Town of East Windsor  
Special Town Meeting  
October 30, 2013

A Special Town Meeting of the Town of East Windsor was held at the Town Hall, 11 Rye Street, Broad Brook, CT on October 30, 2013. The meeting was called to order by First Selectmen, Denise Menard at 7:30 P.M. Motion was made by James Richards and seconded by Dale Nelson to nominate Alan Baker to preside as Moderator. Dale Nelson made a motion to have nominations cease, seconded James Richards. Both motions passed unanimously. Town Clerk, Joanne M. Slater read the call to the meeting. Moderator, Alan Baker read the statement of eligibility to vote.
