

East Windsor Veterans Commission
Regular Meeting Minutes
Thursday, June 4, 2009

Opening:

This meeting was called to order at 7:00 P.M. at the East Windsor Town Hall meeting room by the Chairman, Ernie Teixeira. Treasurer’s Report:

Ed Filipone, Treasurer, submitted his treasurer’s report showing a balance of \$17,044.96 in the EWVC Trust Fund. The EWVC Revolving Fund has a negative balance of (\$2,823.53). The EWVC Memorial Brick account has a balance of \$1,155.00 and a donation of \$100.00 was received.

Ernie Teixeira discussed the need to get started on this task and suggested a special meeting to formulate a plan.

MOTION: George Butenkoff moved to hold a special meeting of the East Windsor Veterans Commission on Thursday, August 13, at 7:00 P.M. at the East Windsor Town Hall meeting room to discuss plans for our 2009 race day fund raising drive. This was seconded by Mark Simmons and carried unanimously.

New/Other Business:

George Butenkoff opened a discussion on the East Windsor Veterans memorial project he was working on. This project had been indefinitely postponed at our last meeting. George said that he was still going to research veterans' names and look into sources of revenue for this project.

Ernie reported on obtaining a sound system for our use at our public events. Ernie contacted Mr. Bob Yosky who will review our plans and will advise us on what would be best for our needs.

Ernie Teixeira presented an invoice for \$350.00 for ten memorial wreaths used for the Memorial Day cemetery and monument displays.

MOTION: George Butenkoff moved to pay the \$350.00 bill for the memorial wreaths from the EWVC Treasury. This was seconded by Ed Filipone and carried unanimously.

Ernie Teixeira reminded those present that our next **SPECIAL** meeting will be held on **Thursday, August 13, 2009, at 7:00 P.M. at Town Hall.**

Hearing of no further business to come before the commission Ernie Teixeira asked for a motion to adjourn.
