PUBLIC HEARING ON PROPOSED REVISION TO SEWER USER CHARGE

The East Windsor Water Pollution Control Authority will hold a public hearing pursuant to Sect. 7-255 of the CGS, at the EWWPCA Admin Bldg, 192 So Water Street, East Windsor, CT on May 31, 2017 during the regularly scheduled meeting which begins at 7:00 pm to give property owners who will have sewer user charges levied against them an opportunity to be heard as to proposed revision to the charges. A copy of proposed revisions to the charge is on file in the Office of the Town Clerk of the Town of East Windsor. The sewer user charge format is based on a unit charge and each unit will pay the sum of \$374 annually. The charge will become effective July 1, 2017, and will be billed annually with total payment due beginning July 1, 2017 and ending June 30, 2018. For bills in excess of \$100, it is at the option of the user to pay in full or in two installments with the second installment being due January 1, 2018. Interest will be charged for delinquent accounts as provided by Sect. 7-258 of the CGS and with a minimum interest charge of \$2.00. The balance of the previously adopted schedule concerning sewer user charges including the number of units which will be assessed against each property owner will remain the same except for those listed below.
