Mr. Alibozek reported that he had received an acceptance letter from the USDA regarding the preliminary engineering report for the North Road Sewer Project. He has a meeting scheduled in the Windsor office of the USDA for March 9, 2010 at 10:00 a.m. Tim Coon of JR Russo and Chairman Anderson will also attend the meeting.

IX. New Business

Superintendent's Report

Mr. Alibozek reported that there has not been any after-hour call in alarms for the months of January and February. This is a direct result of the operator's attention to detail while performing preventative maintenance.

Mr. Alibozek explained that on February 10th, 2010, Phil Smith from CT DEP performed the annual unannounced inspection of our facility. He commended the WPCA for handling the responsibilities while being understaffed. He also mentioned that he would try to write up the need for our roof repairs for our CIP selection, as that concerned him.

Bill Poole, Consulting Engineer Specialist with Schneider Electric met with Mr. Alibozek on February 16th, 2010 to take a look at the ACP-Control Panels along with the components. It is getting to the point where we may need to consider some type of upgrade to our system in the next 3 – 5 years. Schneider owns Square D / Symax, which is what we currently have installed. Allen-Bradley, Modicon and Siemens could also be considered, but if we just upgrade the existing there may be less labor involved.

We had a visit from Board of Selectmen John Burnham and Gil Hayes on February 18th, 2010.

We received our statement regarding the Nitrogen Credit Program for 2009. Our average of 26 pounds per day allows us a credit of \$13,853.

The Public Hearing for proposed amendment to the Sewer Service Area Map has been scheduled for March 2nd, 2010 at 7:00 p.m. at Scout Hall, 28 Abbe Road.

Mr. Alibozek has been invited to attend a Community Conversation with our seniors on April 6th, 2010, from 10:30 a.m. to 11:30 a.m. He would like to attend if it is ok with the Board. The Board thought it was a good idea.

Mr. Alibozek has not yet heard back from Bay State Consultants; they are looking into our electrical rate contract and trying to provide us with savings. This firm is dedicated to work for us as a municipality; they work along with CCM (Connecticut Conference of Municipalities). They believe that this is a good time to gain some savings.

Mr. Alibozek explained the need for an area to garage the utility truck. The truck is currently kept outside with a canvas cover over the hoist. Storing it inside would extend the life span of the truck. It was thought that the old belt thickener building could be renovated for this use. It was agreed that it would be a good idea to provide shelter for the truck.

there is the need to give these properties a special designation. Public comment will be taken at the public hearing on March 2, 2010, but any amendment will be made at a regular WPCA meeting.

Mr. Alibozek reported that they have three qualified applicants for the Superintendent position. They will need to schedule another subcommittee meeting.

Mr. Anderson explained the union negotiations will take place this spring; they need to take a look at pay scales and the contents of the contract.

A budget subcommittee was formed to meet in March and early April; a date and time will be set. The budget subcommittee members are Mr. Anderson, Mr. Godeck and Mr. Tyler.

The superintendent subcommittee will meet on Wednesday, March 10, 2010 at 5:00 p.m. for the first round of interviews; all Board Members are welcome if they would like to attend. Mr. Godeck has supplied an interview score sheet to grade applicants; he is also drafting an agreement and guidelines for the new Superintendent. A formal, second interview will be conducted with the full Board. The applicants will also be brought in to tour the plant and to meet the staff.
