1. <u>Call to Order</u>: Chairman Foran called the meeting to order at 6:30 p.m.

- 3. Approval of Minutes:
  - A. June 9, 2010: Mr. Boule moved, and Ms. Heidtmann seconded, to approve the minutes of June 9, 2010. The motion carried unanimously.
- 4. <u>Communication, Enforcement, and Public Comment:</u>

5. Agent Approval:

<u>25 Skinner Street</u> – Epoch Arts- Mr. Hayden reported the fire marshal asked for there to be a sidewalk placed from the back exit along the edge of the building and up towards the street. Mr Hayden met with them at the site. Putting this sidewalk in is going to improve the area.

**23** Arden Drive – Mr. Hayden provided an agent approval for Mr. & Mrs. Ledas, requesting to place an in ground pool which is just inside the upland review area. They are going to take proper sediment controls, and the work appears to be minor in the wetlands.

- 7. New Application:
  - **A.** Application for Brian Cutler, Traditional Innovations, 265 West High Street, for Filling, Excavation, Land Clearing/Grubbing, Drainage Improvements, Activity in buffer/setback, and Creation of a Wetland, M6/ B12/ L9 in a C zone

Raymond Nelson, professional engineer from Messier & Associates, was before the IWWA to grant permission of re-use of the site, presently occupied by Traditional Innovations, LLC. There was discussion of the past use of the property and what is

being proposed for the property. The building is 27,000 SF which will include the main soccer field, some offices, shops, and a restaurant. They are proposing a wetland mitigation area to mitigate for some of the disturbance and better handle the water flow.

Richard Snarski, soil scientist, wetland scientist, was before the IWWA and explained he delineated the wetland boundary on this property 25 years ago, and has redelineated the boundary last year and the boundary's are very similar with the exception of some of the water ditches have been altered and changed since that time. All of the wetland activity proposed is within a previous gravel bank. The wetland is on a hill side slope and does not pond water. The proposal is to fill .73 acres of created wetlands as a result of the mining for the gravel bank.

Mr. Boule moved, and Mr. Wilson seconded, to consider this application as significant activity and schedule a Public Haring for July 28, 2010, due to the amount of wetlands involved. The motion carried unanimously.

Mr. Wilson moved, and Mr. Wall seconded, to continue the application for Brian Cutler, Traditional Innovations, 265 West High Street, for Filling, Excavation, Land Clearing/Grubbing, Drainage Improvements, Activity in buffer/setback, and Creation of a Wetland, M6/B12/L9 in a C zone until the next regular scheduled meeting, July 28, 2010. The motion carried unanimously.

The members of the IWWA scheduled a site walk for Wednesday, July 14<sup>th</sup>, 2010-They will meet at the site.

Maureen Heidtmann is unseated at this time, Chairman Foran seated Mr. Kavalkovich.

**B.** Application for a Timber Harvest at 149 Chestnut Hill Road, Markham Timber Harvest, Peter Marlow Forest Products LLC. M13 / B32 / L16 in a R-4 Zone

Mr. Peter Lemeris was before the agency to propose a timber harvest on 65 acres of land, 50 will be in the harvest area, and the rest is fields, wetlands, or steep slopes. There is one stream crossing and they will use a portable bridge. 600 trees will be marked for harvest.

Mr. Foran moved, and Ms. Wilson seconded, to move to continue this application to the next regular scheduled meeting, July 28, 2010. The motion carried unanimously.

#### **8. Continued Applications:**

**A.** Application from Town of East Hampton, 103 Main Street, for a parking lot. M6A/B57/L2B

Carla Sylvester was before the agency representing the Town of East Hampton and the Brownfield's Redevelopment agency. The application is proposing to install/construct a parking lot and part of that construction would be to install a liner to prevent the leaching of ground water into the contaminated soils. There would be disturbance of soils within the wetland setbacks. There will be drainage along the creek that will collect run off and it would then be discharged to the creek at a low point in the liner. Mr. Hayden stated all of the contaminated soils would stay on site under the liner.

Mr. Kavalkovich moved, and Mr. Wilson seconded, to approve this application due to the reduction of leeching of toxin materials over the ground water and local water courses, with the conditions on our standard permit (see attached). The motion carried 6-0-1, Scott Hill abstained.

**B.** Application of Christopher M. Valley, 256 Wopowog Road, to place a driveway and culvert an intermittent stream. M22/B54/L2-4.

Steve Motto with Dream Developer was before the Agency, representing Christopher and Michelle Valley of 256 Wopowog Road for discussion of a design of a driveway location. The driveway needed to be moved from the original plan due to excavation that needed to take place for the electrical and cable. A pipe has already been installed to help with the water that was found when excavation took place. Mr. Hayden is comfortable with the remediation.

Mr. Wilson moved, and Mr. Kavalkovich seconded, to approve this application no further technical information for the plan or safeguards for implementation are possible or could reasonable be required in light of the projected effect on wetlands and watercourses. Standard conditions should apply. The motion carried unanimously.

Mr. Lorah moved to nominate Mr. Foran as Chairman, Mr. Kavalkovich moved to elected Mr. Wilson as Vice-Chairman of the Inland Wetland Watercourse Agency. The motions were seconded by Mr. Wall. The motions carried unanimously.
