*Josh Wilson made a motion directing Ruth Checko to write a letter to the property owners to hold the cease and desist in place using the short form permit standard conditions, with the additional condition of a survey to be done prior to and at the finish of construction to assure no further encroachment into the lake. Upon final inspection of town staff, the cease and desist can be lifted. Motion was seconded by Dean Kavalkovich.*
