The Eastham Conservation Commission will hold a public hearing on Tuesday, May 23rd, 2017, at 6PM at the Earle Mountain Room, Eastham Town Hall, 2500 State Highway, pursuant to Massachusetts General Law Ch. 131, Section 40 (Wetlands Protection Act) and the Town of Eastham Wetlands Protection By-Law, Article 34, 1980, in order to consider the following:

**Notice of Intent filed by Shurtleff Rd. LLC.** Applicant proposes installation of a new Title V septic system at property located at 700 Shurtleff Rd., Map 7 Parcel 347.

**Request for Determination of Applicability filed by George Swope.** Applicant proposes removal of invasive species (Russian Olive etc.) and replace with native species (Bayberry, Red Cedar, etc.) at property located at 22 Asparagus Ln., Map 19 Parcel 37.
