The Eastham Conservation Commission will hold a public hearing on Tuesday, December 8, 2015, at 6PM at the Earle Mountain Room, Eastham Town Hall, 2500 State Highway, pursuant to Massachusetts General Law Ch. 131, Section 40 (Wetlands Protection Act) and the Town of Eastham Wetlands Protection By-Law, Article 34, 1980, in order to consider the following:

Notice of Intent filed by Patricia Voke. Applicant proposes installation of a 112 linear feet of rock revetment to protect a post-1978 building and reconstruction of a stairway section at property located at 235 Shurtleff Road, Map 07, Parcel 093.

Notice of Intent filed by Paulo and Ellen Baltazar. Applicant proposes removal and installation of a boat launching ramp in a salt marsh, construction of a retaining wall and sitting wall, stone steps, fire pit, bluestone patio walkways and landings and planting native plants at property located at 285 Corliss Way, Map 21, Parcel 042.

Notice of Intent filed by Elizabeth Gilson. Applicant proposes removal of 68 oak and cherry trees, one pitch pine tree, and vista pruning 48 oak trees and planting native plants at property located at 45 Herring Brook Road, Map 17, Parcel 501A.
