### **Electronic Voting Committee Charge**

The Eastham Board of Selectmen under the Eastham Home Rule Charter Section C9-5-0, established an Ad Hoc committee, which shall be known as the Electronic Voting Committee (EVC), whose purpose is to develop, and support eh use of Electronic Voting Devices at Town Meeting. The Committee shall be made up of five (5) voting members. The Town Clerk, Town Moderator, and one (1) member of the Board of Selectmen are to be liaisons to the Committee and each may appoint a designee to represent them at any time, or for the duration. The Committee shall periodically report to the Board of Selectmen on its progress.

The Electronic Voting Committee is charged with the following responsibilities:

- 1. Research and determine specifications, necessary technical capabilities and qualifications of equipment and vendors.
- 2. Research and identify potential electronic voting equipment and vendors.
- 3. Explore ways to minimize costs by researching possible grant and collaborative activities with the County or other towns.
- 4. Once the Board of Selectmen approves a specific approach, conduct a public hearing and public education sessions on the electronic voting system.
- 5. Recommend to the Town Clerk and Moderator methods of employing e-voting.
- 6. Participate in and review final RFP before issued.
- 7. Participate in interviews of selected respondents.
- 8. Work with and assist the Town Clerk as requested in the implementation of Electronic Voting, including training of tellers and others as may be requested by the Town Clerk.
- 9. After the May 2015 Annual Town Meeting, review strengths and weaknesses of electronic voting and make recommendations to the Board of Selectmen about continuation or abandonment.

Unless extended, the Committee's Service shall be terminating on June 30, 2016.

# THE ALCOHOLIC BEVERAGES CONTROL COMMISSION ("ABCC") ADVISORY M.G.L. c. 138, §15 OFF-PREMISES RETAIL LICENSEES SUNDAY OPENING TIME ALLOWED AT 10:00 A.M.

Effective October 23, 2014<sup>1</sup>, off-premises retail alcoholic beverages licensees (M.G.L. c. 138, §15) will be permitted to sell alcoholic beverages beginning at 10:00 a.m. on Sundays. Although under the law, these licensees are entitled as a matter of right to open at 10:00 a.m. and as such do not need the approval of the Local Licensing Authorities, licensees must notify the Local Licensing Authorities about the change of hours.

The simplest way for licensees to effectuate this change is to follow the process outlined in the CHANGE OF HOURS Application which may be found on our website at <a href="http://www.mass.gov/abcc/pdf/forms/nofeetransmittal.pdf">http://www.mass.gov/abcc/pdf/forms/nofeetransmittal.pdf</a>. Licensees should use this form to notify the Local Licensing Authority of the change in hours and attach a corporate vote authorizing the change. Upon receipt of this request, the Local Licensing Authority must approve it. The Local Licensing Authority should forward an approved "Form 43" with the additional Sunday hours of sale to the ABCC for each licensee affected.

As mentioned above, this law does not go into effect until October 23, 2014. All licensees should ensure that sales of alcoholic beverages take place only on the days and hours approved by the Local Licensing Authority. Licensees who fail to notify the Local Licensing Authority about the change to their hours are prohibited from making sales at an earlier time than those permitted on the face of their license.

As always, all licensees must ensure that they are in compliance with the Laws of the Commonwealth of Massachusetts, and that sales of alcoholic beverages take place only as authorized by applicable law. Re: Policy for Considering Special Municipal Employee Status Requests

Sue and I gathered the sample policy and the discussion of the Board on this matter and developed the draft policy, below for your consideration.

Board of Selectmen's Policy Relating to Granting of Special Municipal Employee Status to Appointed Committee Members, Pursuant to M.G.L. Chapter 268A.

In general, the provisions of Massachusetts General Laws Chapter 268A, Section 17 prohibits a municipal employee from receiving compensation from or acting as agent or attorney for anyone other than the Town in a matter in which the Town has a direct and substantial interest. The Board is aware of the fact that the State Ethics Commission defines "municipal employee" as any person that provides services to the Town, regardless of how that person was hired, elected or appointed, or whether the person receives compensation for his/her services. The Board understands that the State Ethics Commission would find that virtually any matter, which comes before a particular board, or official, which requires official action, is a matter in which the Town has a direct and substantial interest. The provisions of Massachusetts General Laws Chapter 268A, Section 17 is intended to prevent divided loyalties and any appearance of unfair or special advantage.

As the State Ethics Commission states, cities, and towns are entitled to undivided loyalty by their municipal employees. The Board of Selectmen strongly believes that in order to promote public confidence in the administration of the town government a municipal employee's loyalty must lie first with the Town and that Special Municipal Employee status should be granted only in very limited circumstances. The Board is of the opinion that in general, positions, committees and boards that set public policy, have regulatory authority, or have appointing authority should not be granted Special Municipal Employee status.

Therefore, it is the policy of the Board of Selectmen to consider special municipal employee status for any municipal employee except under extraordinary circumstances and using the following process:

- 1. the committee members seeking the status, petitions the Board of Selectmen in writing, stating the reason for the request;
- 2. the applicant discusses the matter with others on the committee as all members will need to be like designated;
- 3. The applicant appears before the Board in a public meeting to discuss the request at which the Board makes a determination to grant or deny the request.

Any request so granted or denied shall be confirmed by a written communication to the applicant.

MEPA Expanded Environmental Notification Form

Dear Mr. Sullivan:

On behalf of the Town of Eastham, attached is the MEPA Expanded Notification Form (ENF) for the proposed Eastham water system. Eastham currently has no municipal water system and relies almost exclusively on private wells for their drinking water. Because the Town also has no municipal wastewater collection and treatment system, these private wells are frequently in close proximity to onsite wastewater disposal systems. This condition has led to the progressive decline in the drinking water quality of these private wells. In addition, because there is no municipal water system the Town has limited ability to provide fire protection.

The need for this municipal water system has been seriously considered and debated by the Eastham community for many years and has been the subject of various Town Meeting articles over this time. At their May 2014 Town Meeting the community voted overwhelmingly to proceed with this water system, which will include the construction of well fields, a storage tank and 45 miles of distribution system piping. This water system will provide a reliable, high quality water supply to a third of the Town's properties and fire protection to 80% of the community. The background, purpose, alternatives considered, environmental characteristics and proposed mitigation measures associated with this project are described in detail in this Expanded ENF.

The Town is requesting that a Single Environmental Impact Report (EIR) be allowed, and therefore this Expanded ENF has been prepared in accordance with 301 CMR 11.05(7) and consists of the form and content of an EIR as described in 301 CMR 11.07(6).

Agencies and persons receiving copies of this Expanded ENF are listed in Appendix J. Public Notice of the Expanded ENF is to be made in two local publications: the Cape Codder on October 17, 2014, and the Cape Cod Times on October 19, 2014.

We have very much appreciated the input and guidance that your staff have provided the Town as this Expanded ENF was being prepared. Please feel free to contact me if you have any questions or need clarification with any of the information contained herein.

Nauset Road and Cable Road Access – Supplemental Information

Dear Mr. Price:

Below and enclosed is supplemental information on the water mains that are proposed to be installed on Nauset and Cable Roads as part of the Eastham water system. As you are aware, portions of Nauset and Cable Roads are located on National Seashore property, the approximate limits of which are shown on the attached Figure 1. Having had some initial discussions on this issue with your staff in August, they requested that we provide some detailed information on the specific location of the water mains and their construction requirements once the design approach is better understood. The preliminary water main design on these two roads have been developed, which provides the location of the water mains, hydrants and valves. The pertinent sections of the preliminary design and construction details are attached.

Our understanding is that the Seashore will review this information and evaluate what the appropriate next steps are for granting access to the Town for the installation and maintenance of these water mains, hydrants, valves and water services.

### Nauset Road Water Main

The Seashore property on Nauset Road is located from the Route 6 intersection, past the Visitor Center to approximately 4,500 feet from that intersection. The attached Drawings, Sheets C-6 through C-8, show the location of the proposed water main on this stretch of Nauset Road. The water main is to be installed within the existing paved roadway area at the locations shown on the Drawings. Hydrants and valves are also indicated on the preliminary design. In addition, the final design plans will show proposed service connections to each developable parcel along the water main route.

Standard water main design procedures were utilized for the preliminary design, and include the following:

- The water main will be installed approximately 5 feet below the roadway surface and will be 12-inch diameter ductile-iron pipe. The trench for the piping will be four feet wide.
- Fire hydrants will be installed at approximately 500 foot intervals at the locations shown on the Drawings. Overall, 12 hydrants are to be installed along this stretch of Nauset Road.
- Temporary pavement will be placed weekly during construction and permanent pavement will be placed approximately six months afterwards to allow for trench settling.
- It is anticipated that the Contractor could install approximately 300 feet of water main each day. Based on this, the water main installation will require approximately three weeks to complete. Additional construction duration is required to install fire hydrant assemblies and

water service connections. The total estimated construction duration on Nauset Road on National Seashore property is approximately five - six weeks.

### Cable Road Water Main

Cable Road runs eastward from Nauset Road. The water main on Cable Road will be connecting the well field located at the Nauset Regional High School to the distribution system at Nauset Road, and will be approximately 1,200 feet on Cable Road. The proposed location of the water main is shown on Sheet C-3. The water main installation will be the same in every respect to that for Nauset Road: it will consist of a 12" water main, be located within the paved roadway area, placed approximately 5' below grade, and finished with temporary and permanent pavement. Hydrants will be installed at approximately 500 foot intervals (two – three hydrants overall). Overall, the construction activities are anticipated to take approximately three weeks to complete.

#### Schedule

The design of the water system is underway and the Town is currently in the process of securing the necessary permits for the project, which we understand will likely include a Special Use Permit for Roadway Access and a Right of Way permit from the Seashore. The Town is looking to complete these design and permitting activities by early 2015 so that Contractors can be solicited and the construction activities can commence by late Spring 2015.



## Drinking Water and Wastewater Infrastructure - New Funding Opportunities

In some areas of Massachusetts, a majority of the existing wastewater and drinking water infrastructure was built following World War II, and it continues to age and slowly deteriorate. In other areas, cities and towns are exploring their options for installing wastewater treatment and disposal facilities for the first time. Water and wastewater infrastructure improvement and replacement projects can be expensive, yet given the potential magnitude of impacts resulting from failure of such infrastructure, proper maintenance and timely replacement is essential. Municipalities and utilities are ultimately responsible for the ongoing process of evaluation, maintenance and replacement of this infrastructure to protect water quality and public health. However, there are significant funding challenges that inhibit the ability of municipalities to fulfill this duty. In response to these funding challenges the Massachusetts legislature passed Chapter 259 of the Acts of 2014. This Memorandum highlights the relevant sections of the new legislation that create the opportunity for a significant new revenue stream for municipal funding of drinking water and wastewater infrastructure.

Massachusetts municipalities have traditionally funded drinking water and wastewater infrastructure projects with monies appropriated from their general funds or monies raised through betterment assessments. The recently enacted legislation, which has been codified at G.L. c.40, §39M, creates an alternative to these traditional funding methods that will enable municipalities to do more effective long term planning for drinking water and wastewater infrastructure projects. Similar to the Community Preservation Act of 2000, the new legislation permits municipalities that accept the law to impose a surcharge on real property at a rate up to, but not exceeding, three per cent (3%) of the real estate tax levy against real property for water infrastructure purposes. As with the CPA, revenues collected through the surcharge are not counted for the purpose of establishing the limit on the local tax levy imposed by Proposition 2½. All monies collected from the surcharge must be deposited into a special fund separate from the general fund known as the Municipal Water Infrastructure Investment Fund. Monies in the Fund may be appropriated by the local legislative body

"exclusively for maintenance, improvements and investments to municipal drinking, wastewater and stormwater assets."

In order to collect the surcharge and establish a Municipal Water Infrastructure Investment Fund, a municipality must follow the two-step process to adopt the law established by G.L. c.40, §39M(f). First, the municipality's legislative body must vote by a majority to accept the statute and designate the surcharge percentage. Thereafter, the voters of a city or town must vote to accept the law at the next regular municipal or state election. The collection of the surcharge would begin the first fiscal year following adoption unless the municipality specifies a future fiscal year in its acceptance vote.

Any city or town that has accepted the law may later revoke its acceptance, or amend the amount of the surcharge, by following the same procedures required for initial acceptance. However, a municipality may not amend its applicable surcharge rate more than once in any 12 month period. Even if a municipality votes to revoke its acceptance of the law, any monies remaining in the fund after revocation must still be expended exclusively for maintenance, improvements and investments to municipal drinking, wastewater and stormwater assets.

The Massachusetts Department of Environmental Protection ("MassDEP") has completed its Technical Review of the BWP SW 22 Landfill Minor Modification application ("Application") regarding the proposed vertical well installation and sampling for Eastham Landfill (the "Landfill"). MassDEP has determined that the Application is administratively and technically complete and hereby approves the Application subject to the Conditions herein.

#### **Submittals:**

The Application included:

- An application Transmittal form assigned number X263430;
- a completed BWP SW-22, Landfill Minor Modification Review application form received on October 9, 2014; and
- A document containing Application supporting information prepared on behalf of the Town of Eastham (the "Applicant"), prepared by Environmental Strategies & Management (the "Consultant") dated September 25, 2014, and received by MassDEP on September 25, 2014.

#### **Project Background**

The Eastham landfill is located on an approximately 38 acre parcel of Town-owned land (the "Site"). The closed Landfill occupies approximately 10.4 acres of land in the southern portion of the Site. A Town operated transfer station has been constructed in the central portion of the Site. The Town's transfer station and Eastham Department of Public Works (DPW) occupies the northern portion of the Site. The Landfill is abutted by residential properties and Old Orchard Road to the south; Old Orchard Road and residential properties to the East; Cape Cod Rail Trail borders the site to the West; the Town's transfer station and DPW to the North. The Landfill operations began in 1937 and ceased in mid-1990s. Groundwater flow is east-southeast toward Old Orchard Road and residential properties.

#### **Assessment Proposal**

The Consultant has proposed to update the Comprehensive Site Assessment (CSA) to further define the nature and extent of 1,4 dioxane in groundwater in the vicinity of the Landfill. This will include the advancement of one electrical conductivity (EC) boring and six temporary vertical profile wells in order to supplement groundwater quality data from existing groundwater monitoring wells and private drinking water wells located in and around the Eastham Landfill. The wells will be utilized to identify aquitards and specific aquifer zones that may be impacted by 1,4 dioxane, and to collect groundwater samples to define the horizontal and vertical extent of 1,4 dioxane in groundwater that is associated with the Landfill. The Consultant states the budget for the Town of Eastham next fiscal year will include funding for the installation of permanent monitoring wells and additional groundwater sampling and monitoring work and an updated CSA Report will be prepared no later than June 30, 2016.

A direct push drill rig will be used to advance a conductivity sensor to a maximum depth of 200 feet. This process will continuously log the subsurface for conductivity to identify lower permeable confining layers. The most suitable aquifer zones for collection of groundwater samples during completion of the profile wells will be determined.

Three profile wells will be completed on the landfill property. The first will be located north of the transfer station and downgradient of the former septage lagoons. Groundwater samples will be collected from up to six depth intervals between 20 and 200 feet, and submitted for laboratory analysis of 1,4 dioxane by EPA Method 8270D SIM (approximate reporting limit of 0.15 ug/l). The two other profile wells on the landfill property will be completed in the area of MS-4S and MW-4D, and in the southern portion of the property near MW-3S, MW-3I, and MW-3D. Groundwater samples from the profile wells will be collected below the screened intervals of the existing monitoring wells (up to four intervals at each location, to a maximum depth of 200 feet).

Three profile wells will be advanced in residential areas outside of the landfill property to define the horizontal and vertical extent of 1,4 dioxane in groundwater. One well will be located in the cul-de-sac at the end of Eldia Way to the northeast of the Landfill, one well will be located on Surrey Drive east of Schoolhouse Road, and the third will be located on conservation land northwest of Walters Way and south of Route 6. Each well will be advanced to a maximum depth of 200 feet and groundwater samples will be collected from up to six different intervals between 20 and 200 feet for analysis of 1,4 dioxane.

An elevation survey will be completed to normalize sampling depths from the profile wells to a defined datum, and to define groundwater flow direction and gradient (horizontally and vertically) in the study area. Existing groundwater monitoring wells and select privately owned drinking water wills will be utilized in the survey. Surface water gauge points will be installed in Moll's Pond and Minister's Pond to relate water table elevation to surface water elevation. After the completion of the survey a complete water level gauging event will be conducted.

Groundwater samples will be collected from existing monitoring wells MW-10, MW-21S, and MW-21D and analyzed for 1,4 dioxane.

The Application includes a proposal to modify the existing Landfill monitoring plan issued in August 2012 by reducing the number of private wells sampled. The Consultant proposed to eliminate monitoring at eleven (11) residences that are receiving bottled water from the Town of Eastham and will continue to receive bottled water until the public drinking water system is installed.

The Application includes approval to conduct a septic study, grey water samples, from residences septic systems depending on the results of the temporary well installation and sampling.

The Application does not make any statement relative to potential landfill gas related issues (methane and non-methane compounds) in and around the landfill. There are concerns regarding landfill gases and its potential migration in the vicinity of some of the temporary well installations. MassDEP is requiring the preparation of a Health and Safety Plan for this assessment project (refer to Condition #2).

#### **Approval with Conditions**

As a result of its review, MassDEP has determined that the submitted documents are satisfactory and in accordance with the authority granted pursuant to Chapter 111, Section 150A of the Massachusetts General Laws hereby approves the temporary well installations and sampling, changes to the Landfill Monitoring Plan and Septic Study proposed at the Eastham Landfill, Eastham, Massachusetts, subject to the following conditions:

- 1) Regulatory Compliance: The Applicant shall fully comply with all applicable local, state and federal laws, regulations and policies, by-laws, ordinances and agreements relative to the activities associated with this project. Applicable federal regulations shall include, but are not limited to 29 CFR Part 1910, OSHA standards governing employee health and safety in the workplace.
- 2) <u>Health and Safety Plan</u>: The Applicants are responsible to ensure that all necessary precautions are taken to protect the health and safety of workers during well installation and sampling events. The Health and Safety Plan shall include training of workers of the hazards associated with landfill gas.
- 3) <u>Notification of Construction</u>: The Applicant shall notify the MassDEP in writing (e-mail is acceptable) when both the temporary vertical well installations and existing groundwater monitoring wells sampling are going to commence; as well as, when they are completed.

- 4) <u>Assessment Data</u>: Within ninety (90) days of the date of this approval the Applicant shall submit a letter report that includes a brief narrative and summary tables.
- 5) <u>Permit Limitations</u>: The issuance of this conditional approval is limited to solid waste regulatory issues and does not relieve the Applicant from the responsibility to comply with all other regulatory or permitting requirements. MassDEP reserves the right to require additional assessment or action, as deemed necessary to protect and maintain the environment free from nuisance conditions, dangers or threats to public health, safety or the environment.

#### **REVIEW OF DECISION**

Pursuant to 310 CMR 19.033(4)(b), if the Applicant is aggrieved by MassDEP's decision to issue this decision it may, within twenty-one days of the date of issuance, file a written request that the decision be deemed provisional, and a written statement of the basis on which the Applicant believes it is aggrieved, together with any supporting materials. Upon timely filing of such a request, the decision shall be deemed a provisional decision with an effective date twenty-one days after MassDEP's receipt of the request. Such a request shall reopen the administrative record, and MassDEP may rescind, supplement, modify, or reaffirm its decision. If MassDEP reaffirms its decision, the decision shall become final decision on the effective date. Failure by the Applicant to exercise the right provided in 310 CMR 19.033(4)(b) shall constitute waiver of the Applicant's right to appeal.

#### RIGHT TO APPEAL

Right to Appeal: This approval has been issued pursuant to M.G.L. Chapter 111, Section 150A, and 310 CMR 19.033: Permit Procedure for an Application for a Permit Modification or Other Approval, of the "Solid Waste Management Regulations". Pursuant to 310 CMR 19.033(5), any person aggrieved by the final permit decision except as provided for under 310 CMR 19.033(4)(b), may file an appeal for judicial review of said decision in accordance with the provisions of M.G.L. Chapter 111, Section 150A and M.G.L. Chapter 30A no later than thirty days of issuance of the final permit decision to the applicant. The standing of a person to file an appeal and the procedures for filing such an appeal shall be governed by the provisions of M.G.L. c. 30A. Unless the person requesting an appeal requests and is granted a stay of the terms and conditions of the permit by a court of competent jurisdiction, the permit decision shall be effective in accordance with the terms of 310 CMR 19.033(3).

Notice of Appeal: Any aggrieved person intending to appeal a final permit decision to the Superior Court shall first provide notice of intention to commence such action. Said notices of intention shall include MassDEP Transmittal No. X263430 and shall identify with particularity the issues and reason why it is believed the final permit decision was not proper. Such notice shall be provided to the Office of General Counsel of MassDEP and the Regional Director for the regional office which processed the permit application, if applicable at least five days prior to filing of an appeal. No allegation shall be made in any judicial appeal of a final permit decision unless the matter complained of was raised at the appropriate point in the administrative review procedures established in 310 CMR 19.000, provided that a matter may be raised upon showing that it is material and that it was not reasonably possible with due diligence to have been raised during such procedures or that matter sought to be raised is of critical importance to the environmental impact of the permitted activity.

**CCRTA Eastham Town Report** 

The Cape Cod Regional Transit Authority (CCRTA) has provided in Eastham 11,510 one-way passenger trips from July 2013 through June 2014 (FY14).

CCRTA provided 59 general public clients in Eastham with DART (Dial-a-Ride Transportation) service during FY14. These clients took a total of 2,495 one-way passenger trips during this time period. Total DART passenger trips in the fifteen towns of Cape Cod were 200,536 in FY13 compared to 220,637 in FY14.

CCRTA FY14 records for the Boston Hospital Transportation service indicated 27 Eastham residents took 103 one-way trips using this service.

A total of 8,803 one-way trips originated in Eastham for the Flex route for the period July 2013 through June 2014; total ridership for the Flex for this period was 78,892.

CCRTA supplied the Eastham Council on Aging with one Mobility Assistance Program (MAP) vehicle that provided 212 rides from July 2013 to June 2014.
