In accordance with Sections C6-5, and C6-2(3) of the Eastham Home Rule Charter, the Board of Selectmen and the Finance Committee will hold a public hearing on Wednesday, April 15, 2015 at 5:00 PM at the Eastham Town Hall, in the Earle Mountain Room, 2500 State Highway, Eastham, MA 02642, on the Proposed FY17-21 Five Year Capital Improvement Plan and FY16 Operating Budget. The Capital Plan, covering all departments and the Eastham Elementary School includes vehicles, technology upgrades, and improvements to municipal buildings. Major additions this year include Rock Harbor Walkway Improvements, Upgrades to Beach Bathrooms, Road Maintenance and Sweeper Replacement, Ambulance Replacement, Police Station Upgrades, and Coastal Erosion Planning & Mitigation.

All amounts and items shown in said capital improvement plan are estimates and are subject to review, refinement, additions and deletions at each Annual Town Meeting where the plan is authorized. I might be a bit late in sending this, but I am writing to add my support to the large group of people who support the town's maintaining Hay Road, which I know is to be voted on soon. I don't live in Eastham, but I do own a house at 50 Lombard Lane which is, it seems, part of a neighborhood which is currently cut off from public access to main roads and highways. I rent the house out seasonally (in the summer).

I view this as a very serious concern, as I'm sure the others do too, primarily because of safety. Not long ago I was driving in that neighborhood with my brother in law, who serves as a firefighter and paramedic for the town of Lexington (and has served as a paramedic for other ambulance companies as well), and he said that he would be nervous trying to drive an ambulance or firetruck down Hay Road or Hoffman Lane (in order to get to Lombard or any of the other roads back there). I really hope the town is able to solve this issue before someone in there really needs an ambulance or fire engine and can't get one quickly enough. Do we really need someone to get hurt before we decide that it's worth solving this issue? I hope not.

PUBLIC HEARING

The Board of Selectmen will hold a public hearing on Wednesday, April 15, 2015 at 5:00 PM at the Eastham Town Hall, in the Earle Mountain Room, 2500 State Highway, Eastham, MA 02642, on proposed amendments to the Town of Eastham Code.

- 1.) Civil Fingerprinting. To allow the local police to perform, upon request and with the permission of the subject, fingerprint based criminal record checks for individuals who are seeking certain licenses such as hawking & peddling, manager of alcoholic beverages, ice cream truck vendor, and dealer of second hand articles.
- 2.) Public Consumption of Marijuana or Tetrahydrocannabinol. This change will restrict the consumption of marijuana or tetrahydrocannabinol while in public or on town owned land, and gives the police the authority to assess a non-criminal fine.
