Committee Appointment

The following is the information needed to make two committee appointments.

Vicky Anderson

The Interview Committee recommends the appointment of Vicky Anderson to the Board of Health.

If the Board appoints her, her first term would commence April 29, 2015 and expire June 30, 2016. She seeks to replace Beverly Knox who resigned 2/9/2015 and whose term was to end June 30, 2016.

Denise Kopasz

The Interview Committee recommends the appointment of Denise Kopasz to the Board of Assessors.

If the Board appoints her, her first term would commence April 29, 2015 and expire June 30, 2017. She seeks to replace Joanna Buffington (term ended 6/30/2014), who became a regular member when Doreen Cahill resigned on 6/16/2014.

Charge To The Board Of Health

9-5-6 Board of Health. A Board of Health of five members shall be appointed by the Board of Selectmen to three year overlapping terms. The Board of Health shall cooperate with the Conservation Commission and the Planning Board and shall participate in joint meetings with them at least once annually.

From Eastham Home Rule Charter - 1992

Board Of Assessors Charge

A Board of Assessors of three members shall be appointed by the Board of Selectmen for three-year overlapping terms. The Board of Selectmen may also appoint one alternate member for a three year term. The role of this alternate will be to exercise the duties and responsibilities of a regular Board of Assessors member in the absence of one or more regular members or in the event of a conflict of interest of one or more members such that a quorum is not present. The alternate and regular members shall possess appropriate qualifications or obtain the necessary training, at town expense, after appointment.

From the Eastham Home Rule Charter-1992
