Hi Joan,

As we discussed a few minutes ago, please find attached a word version of the Selectmen's vote, should the Clerk wish to "cut and paste" the text of the vote into the minutes of the February 1 meeting. I've put the dollar amount of the total town meeting authorization in the Selectmen's vote (\$45,800,000), but this part of the financing through the Trust will be \$24,985,403. (We put in the town meeting authorization amount so that fi the next round of financing through the Trust is \$20,814,597 or less, the Selectmen won't have to vote again, we will be able to use this vote as it covers the full authorization.)

Also, the following agenda item should be sufficient:

"Vote to approve the issuance and details of notes and bonds to the Massachusetts Clean Water Trust authorized under Article 8 of the May 5, 2014 Town Meeting for the Town's water supply and distribution system."

### VOTE OF THE BOARD OF SELECTMEN

I, the Clerk of the Board of Selectmen of the Town of Eastham, Massachusetts (the "Town"), certify that at a meeting of the board held February 1, 2016, of which meeting all members of the board were duly notified and at which a quorum was present, the following vote was passed, all of which appears upon the official record of the board in my custody:

VOTED:

- That the Town shall issue a bond or bonds in an aggregate principal amount not to exceed \$45,800,000 (the "Bonds") pursuant to Chapters 29C and 44 of the General Laws and votes of the Town passed May 5, 2014 (Article 8) and May 21, 2013 (Question No. 1), for construction of drinking water facilities (the "Project");
- (2) that each Bond shall be issued as a single registered security, and sold to the Massachusetts Clean Water Trust (the "Trust") at a price determined pursuant to the Financing Agreement;
- (3) that the Treasurer is authorized to determine the date, the form, the maximum interest rate and the principal maturities of each Bond, and to execute a Financing Agreement (or Agreements) with the Trust with respect to the sale of the Bonds, such date, form and maturities and the specific interest rate or rates of the Bonds to be approved by a majority of the Board of Selectmen and the Treasurer as evidenced by their execution of the Bonds;
- (4) that all action taken to date by the Town and its officers and agents to carry out the Project and its financing, including the execution of any loan commitment or agreement by the Treasurer, are hereby ratified, approved and confirmed; and
- that the Treasurer and the other appropriate Town officials are each hereby authorized to take any and all actions necessary or convenient to carry out the provisions of this vote, including execution and delivery of the Financing Agreements and the Project Regulatory Agreements relating to the Project.

I further certify that the vote was adopted at a meeting open to the public, that no vote was taken by secret ballot, that a notice stating the place, date, time and agenda for the meeting (which agenda included the adoption of the above votes) was filed with the Town Clerk and a copy thereof posted in a manner conspicuously visible to the public at all hours in or on the municipal building that the office of the Town Clerk is located or, if applicable, in accordance with an alternative method of notice prescribed or approved by the Attorney General as set forth in 940 CMR 29.03(2)(b), at least 48 hours, not including Saturdays, Sundays and legal holidays, prior to the time of the meeting and remained so posted at the time of the meeting, that no deliberations or decision in connection with the sale of the Bonds were taken in executive session, all in accordance with G.L. c.30A, §§18-25 as amended. I further certify that the vote has not been amended, supplemented or revoked and remains in effect on this date.







"Vote to establish a special gift fund for the purpose of Affordable Housing Data Analysis/Studies under MGL Chapter 44 Section 53A; monies shall be deposited with the treasurer and held as a separate account and may be expended for this purpose without further appropriation."

### GIFT AGREEMENT PURSUANT TO G.L. c.44, §53A

WHEREAS, Stratford Capital Group, LLC of 100 Corporate Place, Suite 404, Peabody, MA 01960 ("Stratford") wishes to make a gift to the Town of Eastham ("Town"), by and through the Board of Selectmen ("Board"), to assist the Town with reviewing an application ("LIP Application") by Stratford to the Board for endorsement of a Local Initiative Project regarding property located at 4790 State Highway, Eastham, MA ("Property").;

WHEREAS, the Board wishes to review the LIP Application, but lacks the necessary funding for same, to allow the Board to obtain legal advice and peer review of the necessary materials; and


WHEREAS, Stratford provides the Town herewith with \$12,000 in funds to be placed into a gift account under G.L. c.44, §53A; and

NOW, THEREFORE, the Town, by and through the Board, and Stratford agree as follows.

- 1. Stratford hereby provides the Town's Treasurer with the sum of \$12,000.00 under G.L. c.44, §53A to be deposited by the Treasurer in an interest bearing account to be expended at the direction of the Board, exclusively for the following purposes:
  - i. The Town's reasonable legal fees to obtain advice from Town Counsel Kopelman and Paige, PC regarding preparation and negotiation of a potential Memorandum of Agreement to support potential endorsement of the LIP, including preparation of the Memorandum of Agreement and attendance at meetings held in the Town to review and negotiate the terms of the Memorandum of Agreement from .
  - ii. The Town's reasonable peer review costs by a qualified professional to peer review:
    - \* Stratford's marketing plan;
    - \* Stratford's traffic reports;
    - \* Fiscal impact reports; and
    - \* All available evidence to evaluate the Town's need to request a local preference for Town residents for the affordable units;
  - iii. The Town's reasonable costs to develop a strategy to promote readiness of eligible local residents to enter into the lottery for the affordable units when they become available, to assist with the exercise of any local preference.

- 2. The gift funds may be used by the Town, up to the \$12,000.00, to pay for the reasonable legal costs and the technical peer review incurred by the Town to review and evaluate the LIP Application and develop a potential MOA as set forth above and for any related purpose, but for no other purpose without Stratford's approval.
- 3. Peer review contracts shall be in writing and shall be for "not to exceed amounts," except for relevant Town Counsel services from November 15, 2015 through conclusion of review of the Application by the Board.
- 4. Stratford may replenish the Gift Account if there is any shortfall, in amounts it deems are appropriate, to provide additional funds to the Town to support its review the Application, but this agreement shall be modified by majority vote of the Board of Selectmen to authorize receipt and expenditure of the gift funds..
- 5. It is hereby acknowledged the Town shall have the right, but not the obligation, to use the funds, including any accrued interest, obtained hereunder for the stated purpose and that the Town shall not be deemed to have waived its right to use the funds or be deemed guilty of laches if the Town delays in using the funds.
- 6. Once the Board notifies the Town Treasurer in writing that the costs detailed above have been fully paid and notify the Treasurer of the amount of the costs and fees, then this gift account shall be closed and any excess funds remaining in the gift account shall be returned to Stratford or its written assign after the work contemplated hereunder has been completed to the Town's satisfaction, which satisfaction shall be evidenced by a written determination of the Board. Any interest accrued under the gift account may be used for any purpose allowed under this agreement.
- 7. Acceptance of the gift funds and expenditure of the gift funds is to allow the Town and the Board to evaluate the Application and no promise or representation has been made to Stratford in exchange for the funds, other than that the funds shall be used to review and evaluate and act upon the Application in good faith.

Or perhaps the renter could be allowed to rent with an option to buy? This way the owner gets to build equity and a credit history rather than have their rent go into the black hole. I spent the first 10 years of my professional life renting—a total waste of money. Had I had the option of securing a loan with a modest down payment I would have jumped at it. In fact, when I was single and on a limited social services salary I had applied for one such affordable condo project in Salem but did not get selected.

When we finally saved enough for a down payment we purchased a condo in Dover, NH which gave us the equity and credit history to then purchase a single family and then the motel complex.

Our goal should be to encourage young families and people (or seniors) on low or fixed incomes to be able to rent *or purchase* affordable property in Eastham. As a parent of two young adults now off Cape who found limited opportunities for employment or affordable housing on the Cape I would love nothing better than to give young Cape Codders a reason to stay here.

I also have some disdain for a foreign owned corporation (Stop & Shop) purchasing this parcel in Eastham not because they wanted to relocate here but to place deed restrictions on it effectively dictating to the Town of Eastham how the parcel can or can't be used in order to prevent any mixed use of the property and prevent any competition. I try to do most of my shopping at Friends Market now as my little protest and although it is closer and more convenient I shop there more as a convenience store. Corporate shenanigans are one of my pet peeves.

Our goal should be to encourage young families and people (or seniors) on low or fixed incomes to be able to rent *or purchase* affordable property in Eastham. As a parent of two young adults now off Cape who found limited opportunities for employment or affordable housing on the Cape I would love nothing better than to give young Cape Codders a reason to stay here.

I also have some disdain for a foreign owned corporation (Stop & Shop) purchasing this parcel in Eastham not because they wanted to relocate here but to place deed restrictions on it effectively dictating to the Town of Eastham how the parcel can or can't be used in order to prevent any mixed use of the property and prevent any competition. I try to do most of my shopping at Friends Market now as my little protest and although it is closer and more convenient I shop there more as a convenience store. Corporate shenanigans are one of my pet peeves.
