## Approval of Minutes

The approval of the Minutes of May $5^{\text {th }} 2003$ was deferred to the next meeting due to the Executive Secretary's absence through illness.

## Administrative

The Board of Selectmen approved and signed the Warrant for the First Billing 2003.
The Board of Selectmen approved an abatement to correct card errors and depreciation values for Map 2 Lot 42, and denied an abatement request for Map 22 Lot 22

The Board reviewed the requests for Exempt Taxation Status forms A-9 and A-12, and approved the following for exemption, motion Oppenneer, second Albanese, vote 3-0.

- Union Church of Enfield Center (Religious Exemption)
- Evangelical Lutheran Church (Religious Exemption)
- La Salette of Enfield Inc (Religious Exemption)
- Enfield Historical Society (Charitable Exemption)
- St. Helena Parish (Religious Exemption)
- Enfield United Methodist Church (Religious Exemption)

The board granted partial exemptions in the following:

- Living Waters Bible Church Inc: (Religious Exemption Request) Motion Oppenneer, second Reed, to exempt buildings and land appurtenant excluding 50 acres not directly used and occupied by the Church, vote 3-0.
- Dartmouth Yacht Club: (Educational Request) Motion Oppenneer, second Reed, to exempt $75 \%$ of the property for educational purposes, and to tax the remaining $25 \%$, vote $2-0$, Albanese abstaining due to conflict of interest.

The Board of Selectmen deferred decisions for the following requests pending further information and fact-finding:

- Enfield Outing Club requesting Charitable Exemption
- Oak Grove Cemetery Association requesting Charitable Exemption
- Humane Society requesting Charitable Exemption
