**CALL TO ORDER**

Mrs. Reed called the meeting to order at 5:30 pm.

**APPROVAL OF MINUTES**

**Regular Session Minutes**

The Board reviewed the minutes of June 5, 2000. Minor typographical errors will be corrected. Mr. Oppenneer moved to accept the minutes of June 5, 2000 as corrected; Mrs. Reed seconded, vote unanimous.

**Non-Public Session**

Mrs. Reed moved to enter non-public session at 5:37 pm.; Mr. Crate seconded. Roll call vote: Mrs. Reed, yes; Mr. Crate, yes; Mr. Oppenneer. Mr. Oppenneer and the administrative staff left the meeting at this time.

Mrs. Reed moved to come out of non-public session at 7:07 pm.; Mr. Crate seconded, vote unanimous. Mr. Oppenneer and the administrative staff returned to the meeting.

Mrs. Reed moved to seal the minutes of the non-public session; Mr. Crate seconded; vote unanimous.

**Highway Superintendent Position**

The Board received copies of the job description for the Highway Superintendent position. The Board had no suggestions for changes. Mr. Griffin recommended advertising for the position. Current employees are welcome to apply.

**Selectmen's Meeting Schedule**

The Selectmen's meeting normally scheduled for the first Monday of July has been moved to Wednesday, July 5<sup>th</sup>.

**Shaker Bridge Environmental Issues**

The Board considered a draft letter to the NH Department of Transportation regarding environmental issues of concern to the Town during the replacement of the Shaker Bridge of Mascoma Lake. Some changes were recommended. A new draft will be brought to the selectmen for consideration at the July 5<sup>th</sup> meeting.

**Sewer Connection**

The Board considered a request from Ralph Eames for a sewer connection for a new house at Lower Shaker Village. Ken Daniels, Director of Public Works, recommends approval. Mrs. Reed moved to approve the sewer connection as requested; Mr. Oppenheer seconded; vote unanimous.

**Committee Appointments**

Mr. Crate moved to appoint Howard Walton to the Conservation Commission as a regular member; Mrs. Reed seconded; vote unanimous. Mr. Walton fills the position previously held by James C. Gerding, Sr.

Mr. Crate moved to appoint Terry Finsterbusch to the Conservation Commission as an alternate member; Mrs. Reed seconded; vote unanimous.

**Letter of Thanks**

The Board signed a letter thanking All Waste Services for providing and hauling two 30-yard containers of refuse at no cost to either the Town or the Enfield Village Association for the May 20<sup>th</sup> cleanup in Enfield's town center. All Waste Services has exhibited positive community spirit for which we are most grateful.

Mr. Oppenheer moved to approve Veterans Tax Credits as presented; Mr. Crate seconded, vote unanimous.
