Steve talked about what goals and objectives might mean here. Levels of Service for the departments, like, we have seven police officers - is that OK? PWD can plow town in 1.5 hours – is that OK? Reduce and accept a longer clearing time? The EBC should discuss matters like that.

Mike's summary of the general process, which he read out to the group and which they said is about right:

Town (steve) gives us the budget,

EBC members meet with their departments and learn why the departments asked for what they did.

EBC comes back together to discuss what we've learned. Liaisons act as advocates for their departments.

EBC works out a budget to present at town meeting for a vote. We present it and if they want, the select board may propose an amendment – very rare.
